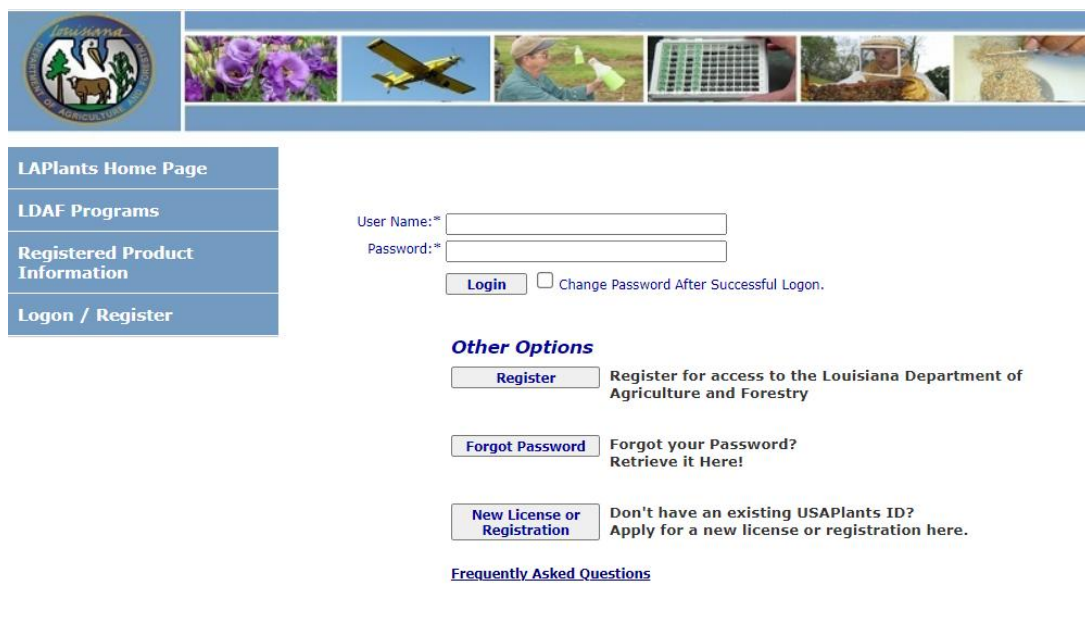

Buttons

- **Get Results** – This button fetches the products for the year displayed in the dropdown menu immediately to the left. This is useful for examining the history of products registered for the company.
- **Add New** – This button starts the process of adding a new product to the company's portfolio. This function only works for the current year and cannot be used to add backdated products to the database.
- **Export to Excel** – This button generates an excel file that contains all the products within a company's portfolio for the current year. Any relevant registration data (i.e. product ID, product status, etc.) is also included for each product in the Excel file.
- **Print Certificate for ____** - This button generates a registration certificate that contains the products, product ID # and status for a company's entire yearly portfolio.

Add New Product

Clicking the “Add New” button will bring up the Feed Manufacturers Product Edit screen. This feature is optional. Companies can perform their annual registration and pay online without adding any products through the online portal.

This is the fastest way to submit a product registration request. Please fill out the information below. A copy of your current label is required for each product and grade. You do not need a separate label for each package weight. Portable Document Format (PDF) is the preferred format for labels, but image formats (JPG, TIFF, BMP) and Microsoft Word files are also acceptable. The label must be legible.

Instructions to Register for LDAF Feed Program

Fields

- Product Name – The product name should be easily discernible from the label provided.
Example: New Cat Food is formulated to meet the nutritional levels established by the AAFCO Cat Food Nutrient Profiles for all life stages. New Cat Food is the name that should be used for the new product.
- Product Code – This is any internal code used by the company to identify the product.
- Website – Optional field that contains the website specific to the brand
- Product Purpose – If the label has a purpose statement, it can be entered here.
- Additional Information – If there is any additional information that may be relevant to the label review process, please input it in this box.
- Product Composition – This is the section where all the guaranteed analysis values are entered.

Product label upload

This section handles the process of uploading digital labels into the database. PDF is the preferred file format, however, JPG, BMP, PNG and TIFF files plus MSOffice file formats can be handled by this office. Scanned images are acceptable only if they are legible. To upload a file, click the “Add File” button.

The following commodities are hereby declared exempt from the definition of commercial feed, under the provisions of R.S. 3:1391(3): raw milk, raw meat, and hay, straw, stover, silages, cobs, husks and hulls when unprocessed, and when not mixed or intermixed with other materials; provided that these commodities are not adulterated within the meaning of R.S. 3:1396.

Additionally, Remedy products are not required to register with the LDAF Feed Program. Under no circumstances should products containing hemp register with the LDAF Feed Program.

Zero Quarterly Tonnage

If a company wishes to report zero tons for the quarter, then select the checkbox for “Zero Quarterly Tonnage”, click the “Save” button and then the “Back” button to complete reporting.

Note that companies with the small package exception will not be automatically charged the minimum \$10 fee. The small package/specialty fee companies are only required to turn in tonnage reports quarterly.

Non-Zero Quarterly Tonnage

Please Fill in the “Total Tons:” blank and then enter the corresponding # of tons in Feed/Pet Food (Commodities) &/or Feed Ingredients (Commodities). This information must be added before you may proceed further. After adding the backgrounding information click the “Save” button and then the “Submit & Back” button to add the report.

After adding the tonnage report, USAPlants will return to this screen.
