TERMS AND CONDITIONS AND CHARGING CRITERIA

Occupational health professionals and specialists are generally charged on a time basis. The total duration depends on the time the expert spends reviewing the patient's medical history and recording information in the patient information system or organisational reports. As a rule, the minimum charge for preventive occupational health work aimed at a work community/organisation is 30 minutes and for individual work 15 minutes.

The service provider has the right to charge an initiation fee of 400,00 € for a new contract if, for reasons attributable to the customer company, it has not been possible to initiate operations according to good occupational healthcare practices (based on a workplace survey and action plan) within three months of signing the contract. The payment will cover the expenses of establishing the service.

Service reactivation fee

Reactivation fee of an occupational health agreement in cases in which the agreement was terminated by Pihlajalinna due to the customer's unpaid bills after the customer was sent email notices about the matter. We will charge 400,00 € to reopen an occupational health agreement.

Appointments cancelled contrary to the terms/no-show appointments

Scheduled appointments shall be cancelled 24 hours before the start of the appointment. If the person who booked the appointment does not show up to the appointment and has not cancelled it at least 24 hours beforehand, the customer organisation will be charged for the reserved time according to the price list. An invoicing fee will be added. Any appointments agreed with the organisation must be cancelled at least five (5) working days before the appointment. The basis of charging for an unused appointment or appointments cancelled contrary to the terms is the booked time.

Processing fee

The processing fee 14,90 € is charged together with the invoice for a no-show appointment or an appointment cancelled contrary to the cancellation policy. The processing fee consists of the cost of background work and services related to the booking service and processing of cancellations, such as the maintenance of digital services. In addition, the processing fee covers the invoicing costs.

VAT policy

VAT is not charged on the sale of occupational healthcare services that are considered healthcare and medical services under the VAT Act. To the extent that taxable services or products are sold alongside healthcare services, VAT will be added to the prices. Examples of VAT-liable occupational healthcare services include preventive services directed at the organisation. If a sale is subsequently deemed taxable, the seller has the right to charge the buyer VAT at the applicable tax rate.

Pricing of occupational health specialist services

When a service is provided by an occupational health specialist, 5% is added to the price.

Group training

We invoice group training in advance. If a participant cancels their participation fewer than 10 days before the start of the training, we charge 50 % of the price of the training session if no satisfactory illness-related reason is provided. If the participant is unable to attend a training session, no alternative training will be organised; instead, the coach provides the content of the session to the person for independent learning.

Coordination work for occupational health

Coordination of occupational healthcare for a national or multi-site (more than one occupational health contract statuses) customer organisation. Coordination work is described in the action plan.

Travel costs

Charged based on time spent and means of transport. Travel time is charged at the first half hour according to the hourly rates specific to the occupational group.

General fee (reimbursed by Kela)

41,50 €/employee/year

The general and service fees include: Maintaining register data in the data system, nationwide customer service and maintaining online booking systems, registration and advisory staff services, archiving health data in the data system and archiving written medical data and invoicing functions.

Service fees (not reimbursable by Kela)

The occupational health service fee is charged annually based on the number of employees in the company. The service fee includes invoicing services (excluding subcontracting invoicing surcharge and paper invoices as well as invoices for appointments cancelled contrary to terms and uncanceled appointments), archiving services, the opportunity of employees to view their own data via the Health application, Occupational Health Portal reporting, maintenance of personnel data and other content. The management of the occupational health portal is charged separately.

Additional services of the occupational health portal

Data transfer connection

The purpose of the data transfer connection service is to transfer the basic staff data and any self-reported absences of employees from the customer's data systems to Pihlajalinna's data systems automatically. Ask for a quotation.

Work ability support app

Pihlajalinna's work ability support application is an addition to the Occupational Health Portal, which is intended as a tool for managers to manage work ability. The work ability support application facilitates impactful cooperation to support work ability management. Ask for a quotation.

VAT is added to the price. In addition, if we coordinate subcontracted occupational health services in locations where Pihlajalinna would be able to offer its own services, we charge a subcontracting general fee (not reimbursable by Kela). The fee is based on the subcontracting prices plus VAT %.
