3. Cigna + Oscar's determination of group size as it pertains to program eligibility will be counted based upon eligible enrolled employees at the time of initial enrollment with Cigna + Oscar.
4. Only licensed and appointed agents who are contracted with Cigna + Oscar are eligible for the bonus.
5. The producer must be the Agent of Record and hold an appointment with Cigna + Oscar on both the effective date of coverage and at the time the bonus is paid.
6. Eligible groups must effectuate and pay at least three months premium in order to qualify for the broker bonus program.
7. Bonus payments will be made on or around the commissions payout dates of the beginning of the month following enrollment, once the coverage duration and premium payment requirements have been met.
8. Producers may not combine, transfer or otherwise aggregate business with other producers for the purposes of bonus program eligibility.
9. Compensation will be allocated based upon commissions split on the case.
10. Disagreements or disputes regarding this program or the interpretation of rules or payout amounts will be resolved at the sole discretion of Oscar. Oscar may amend or discontinue the terms of the program at any time without advance notice.
