Step 1: Create an account or log in to the Oscar Broker Portal at business.hioscar.com.

What's in the Medicare Advantage Certification Checklist

There are just six (6) required tasks in the Certification Checklist:

- 1. Electronically sign the Medicare Advantage producer agreement.
 - a. You can access the signed producer agreement anytime from the Medicare Certifications page in the Oscar Broker Portal.
- 2. Complete your AHIP training (if you haven't already) and transmit your scores to Oscar Health.
- 3. Get appointed in Florida, New York and/or Texas.
 - a. Please note: We are offering Medicare Advantage plans in Florida (NEW), New York, and Texas for 2021.
- 4. Add or update your FMO affiliation, if applicable.
 - a. If you cannot find your FMO, please contact our Broker Support Team at 1-855-672-2713 or <u>brokers@hioscar.com</u>.
- 5. Complete the Oscar Broker Certification Training.
 - a. Review all contents in the Oscar Broker Certification Training. You can also download and print the course materials for your convenience.
- 6. Complete and pass the Oscar Broker Certification Assessment.
 - a. You will have five (5) attempts to pass the assessment with a score of 90% or above.

What happens after you complete your certification

Congratulations on completing your 2021 Medicare Advantage Certification! You can start enrolling clients on October 15, 2020. In the meantime, make sure you're prepared to sell by setting up and exploring your Oscar Medicare enrollment portal account.

Here's how to get started:

Activate your Medicare enrollment portal account (if you haven't already)

Oscar uses a separate portal to accept Medicare Advantage enrollments. If you used the Oscar Medicare enrollment portal to enroll 2020 policies or have previously activated your account, you can follow steps 1-3 below to log in to your account.

To activate your Medicare enrollment portal account, use the following steps:

- 1. Log in to your Oscar Broker account at business.hioscar.com
- 2. Click on **Medicare book** at the top right of the page.
- 3. Click the **Enroll new policy** or **Explore Medicare portal** button, which will take you to the Oscar Medicare enrollment portal login page.
- 4. Claim your account by clicking **Reset Password**.
- 5. On the Reset Password page, enter the same email address you use to log in to your Oscar Broker account under both **Username** and **Email address**.
- 6. Check your inbox for an email with the subject line "Cavulus Account Reset". This is the email containing your password reset link.
- 7. Follow the link in the email to create a secure password and activate your account.

Once your password is set, you can always access the Oscar Medicare enrollment portal through your Oscar Broker account (repeat steps 1-3).

Add leads to the Oscar Medicare enrollment portal

In addition to enrollments, the Medicare enrollment portal can also be used for lead management. You can add leads anytime (even before October 15) using these steps:

- 1. Access the Oscar Medicare enrollment portal by following steps 1-3 above.
- 2. Log in using your email address and the password you set above.
- 3. Click on the Lead Entry tab.
- 4. Complete the form to create a new lead. You will be asked to provide basic required information: first and last name, phone number, zip code, and contact consent.
- 5. View or edit your leads anytime from the Lead Management tab
