1. Summary

At the top of the report, you will find a general diagnosis in the form of a gauge together with traffic lights showing the main characteristics of the stock under analysis such as price, variations and classic identifiers.

below, you will find the main conclusions for each section analysed (Valuation, Analysts, Technical Analysis, Fundamentals and Risk). A green circle indicates a favourable opinion, a grey circle a neutral opinion and a red circle a negative opinion. Clicking on a circle takes you to the relevant section. In the margin, you will find charts showing price movements and performance of the stock. Lower down, there are the key figures as well as a company profile.

you will also find the main players in the sector and - an innovative feature - investment tips for the sector in the form of a list of top-scoring companies.

2. Different sections

These go into specific aspects of the stock under analysis in detail. A set of colours (green, grey, red) is displayed in the banner at the top of each section, depending on the diagnosis. Green means good, grey means neutral and red means not so good.

VALUATION SECTION

this section helps you take advantage of overreactions, based on a clear opinion (Underpriced, Correctly priced, Overpriced) drawn from a variety of valuation methods.

this summarises the views of market professionals, based on straightforward analysis (Underperform, Outperform, Neutral). This contains full details of recommendations, price targets, estimates of turnover, profits, dividends and in particular their adjustments over several periods.

this section immediately gives you a clear, complete view of companies' financial health, based on an analysis of the main aggregates and financial ratios (cash flow, balance sheets and profit and loss accounts).
