

Sport Nation x Tavendale and Partners - Terms and Conditions

1. All Entrants (“**Entrants**”) who participate in this Sport Nation x Tavendale and Partners competition (the “**Competition**”) are deemed to accept these terms and conditions of entry. Any entries in this Competition that do not comply with these terms and conditions will be deemed invalid and Entain New Zealand Limited (“**Sport Nation**”) takes no responsibility for such entries. All times given in these terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.

Competition Period

2. The Competition will commence on Monday 18th May 2026 at 12:00am and conclude on Monday 25th May 2026 at 12:00pm (the “**Competition Period**”).

Eligible Entrants

3. To be eligible for entry into this Competition all Entrants must:
