While all SSE Green Electricity is sourced from our own UK wind and hydro generation,<sup>1</sup> an SSE Corporate Power Purchase Agreement (CPPA) allows you to buy volume from a specific wind farm at a fixed price, giving you full traceability. Your tangible link with a wind farm is a compelling way to show how you're reducing emissions.

A CPPA directly impacts the price you pay for energy, helping your business increase budget certainty and enabling you to refine your price risk management strategy.

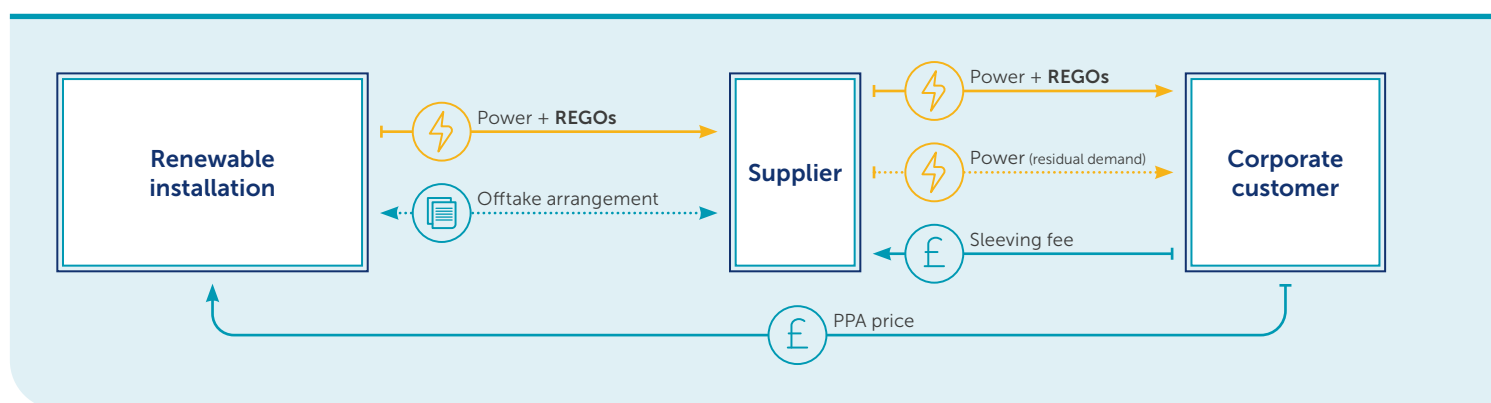

# YOUR DIRECT LINK TO GREEN ENERGY GENERATION

Historically, CPPAs have been complex to implement, limiting the number of customers who could access them. SSE CPPA removes this complexity, and makes the benefits of purchasing renewable energy through CPPAs accessible to many more businesses across Britain.

As an example, the traditional CPPA model requires customers to contract directly with a renewable electricity generator, with a separate contract to the energy supply agreement. The supplier, generator and customer then have to arrange for the power to be embedded and netted off from the overall demand. This can be a complicated and lengthy process.



Another challenge with the traditional model is that customers typically have to find a generator which can match their requirements on the volume to be supplied, the term over which this volume is to be supplied, and all the terms and conditions that come with these types of agreements. Finding this “perfect match” between customer and generator can be challenging.

## CPPAs made simple

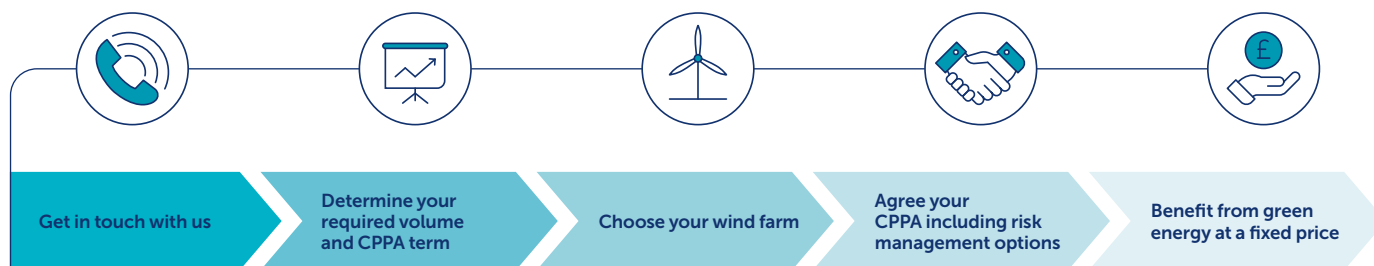
We’ve designed SSE CPPA to remove those barriers, and enable a wider range of customers to purchase energy directly from one of SSE’s renewable assets.<sup>1</sup>



SSE CPPA allows you to buy an agreed amount of green energy, for a fixed price, from one of our operational UK wind farms.<sup>1</sup> And rather than you having to negotiate separate contracts, everything is managed through your existing flexible supply agreement.

**Put simply:** we purchase the power from our wind farms on your behalf and transfer it directly into your supply contract. We’ve done the hard work for you. There are no separate contracts, no need for lengthy negotiations – you only have to speak to us, as you do now.

# STEPS TO GETTING A CPPA



We're offering the flexibility to choose a shorter term commitment and how much volume you want to buy.

If you want to buy a wind farm's entire output that's great; but if you want to buy a smaller amount, that's fine too. We can do this by splitting the volume from a single wind farm across multiple customers.

And you can sign up to SSE CPPA for as little as a year, up to five years initially – there's no long-term commitment required. You'll pay a fixed price for the electricity you buy from your agreed asset for the duration of your CPPA agreement with us.

Your CPPA will include Renewable Energy Guarantees of Origin (REGOs), so you can verify that each kilowatt of electricity is sourced from your chosen wind farm.

## WHO CAN GET SSE CPPA?

Currently, SSE CPPA is available to:

- Organisations or collective buying groups that use at least 30GWh electricity annually.
- SSE Energy Solutions supply customers, with a flexible supply contract.



## || RUNNING ENGLAND'S LARGEST ONSHORE WIND FARM

Keadby wind farm in Lincolnshire contributes 68MW to SSE's 4GW of renewable energy capacity.<sup>1</sup> It's expected to displace 718,800 equivalent tonnes of CO<sub>2</sub> throughout its lifetime.

SSE has another 7GW of on- and off-shore wind power in the pipeline, to build on our position as the UK and Ireland's largest renewable electricity generator.

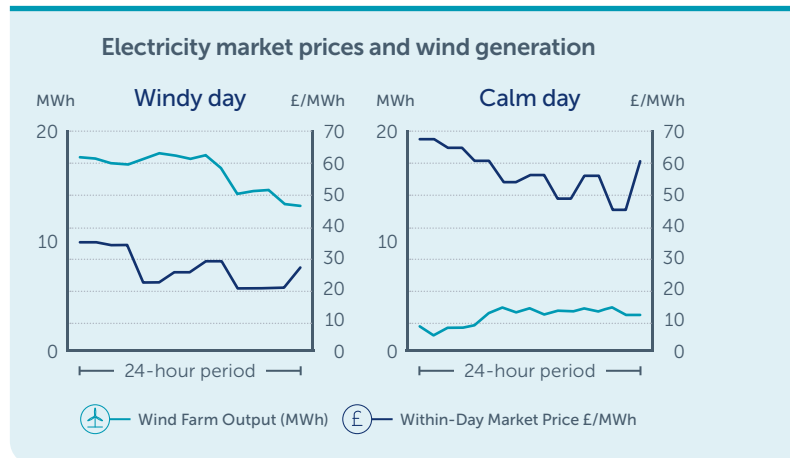
By committing to buy electricity from one of our existing wind farms, you're supporting green generation and giving us the confidence to invest in new renewable assets in the future.

# YOUR POWER YOUR CHOICE

Our CPPA allows you to buy the output of your chosen wind farm, which will vary depending on the weather. If you don't want to be exposed to the costs of managing this variability, we offer risk management services.

If you're happy to buy the output of the wind farm, regardless of what happens with the weather, that's no problem. It means you'll have to settle your residual demand against real-time market prices. So on days when the wind is blowing hard, you won't have very much left to buy; and on days when it's not blowing at all, you'll have to buy all your demand from the market.

However, we know not all customers are comfortable purchasing in this way. So we offer two risk management options, the costs of which are included in your total CPPA price.

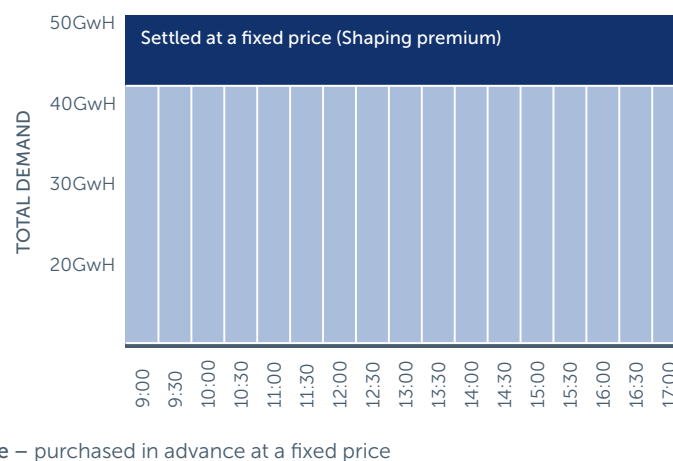
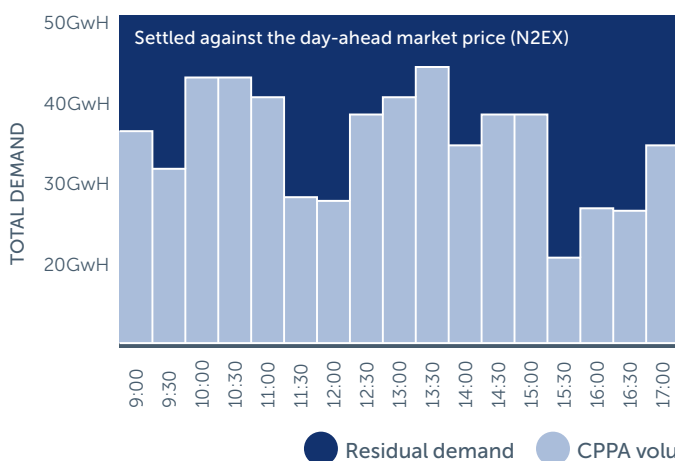


## Day Ahead

We forecast what the wind farm will generate the following day, and guarantee that you'll receive the forecast volume and profile.

## Baseload

We forecast what the wind farm will generate over the year, and guarantee you a baseload equivalent volume – every half hour over the year.
