Band 03 AQ between 293,001 - 732,000 kWh
Band 04 AQ between 732,001 - 2,196,000 kWh
Band 05 AQ between 2,196,001 - 5,860,000 kWh
Band 06 AQ between 5,860,001 - 14,650,000 kWh
Band 07 AQ between 14,650,001 - 29,300,000 kWh
Band 08 AQ between 29,300,001 - 58,600,000 kWh
Band 09 AQ between 58,600,000 - 900,000,000,000 kWh
