With 3.5 million customers in 24 European markets, N26 is one of the fastest growing banks in Europe, operating with a full bank license since 2016. In the US, N26 operates via its wholly owned subsidiary N26 Inc. based in New York.

The N26 app attracts over 10,000 new users every day in Europe primarily through word of mouth about its simple yet elegant design and usability.
