Each bid shall clearly include the bidder's particulars, the offered price, a declaration that he is aware of and unreservedly accepts the Terms for Sale of Property, the bidder's signature, and the date.

Before the delivery of his bid, each bidder shall deposit with the auction Committee a sum equal to 10% of the reserve (i.e. minimum bid) price in the form of a Letter of Guarantee (Bank Guarantee) issued by a bank or a Banker's draft to the order of **ΕΘΝΙΚΗ HELLENIC GENERAL INSURANCE S.A.**, guaranteeing participation in the auction and, if the applicant is eventually declared the highest bidder, observance of the Terms of Sale.

The eventual winning bidder shall, before finalization of the auction process (which occurs upon delivery to **ΕΘΝΙΚΗ INSURANCE** of the relevant guarantee), adjust – if necessary – the guarantee previously submitted to 10% of the amount of his bid, supplementing the amount with a Banker's Draft to the order of **ΕΘΝΙΚΗ HELLENIC GENERAL INSURANCE S.A.** or with a Letter of Guarantee issued by a bank, to secure observance of the Terms of Sale, but in no event shall this mean that the property is conclusively awarded.
