If you're a freelancer, ecommerce seller, SaaS founder or agency owner **outside the US**, you've probably hit the same wall everyone does: you want a US LLC so you can accept Stripe, bill clients in dollars and look credible to American customers — but you don't have an SSN, a US address, or any idea how the IRS works. That's the exact problem Doola was built to solve.

In one annual subscription, Doola files your LLC (typically in Wyoming or Delaware), applies for your **EIN with the IRS without requiring an SSN or ITIN**, gives you a US business address and registered agent, prepares your operating agreement, and walks you through opening a real US business bank account remotely with partners like Mercury or Relay. On the higher tier it also handles your bookkeeping and annual federal tax filing.

Frequently Asked Questions

Q Is Doola legit and safe to use?

Yes. Doola is a US-based company founded in 2020 (originally StartPack) and headquartered in New York. It holds a 4.7-star rating across 2,000+ Trustpilot reviews and has helped tens of thousands of founders in 175+ countries form US companies.

Q Can I get an EIN with Doola without an SSN?

Yes — this is Doola's standout feature. Doola handles the full EIN application directly with the IRS for non-US residents who have no SSN or ITIN, removing the single biggest blocker most foreign founders hit.

Q How much does Doola cost in 2026?

Starter is \$297/year and Total Compliance is \$1,999/year, plus state fees. With our link a 10% discount is automatically applied at checkout — bringing Starter to roughly \$267 and Total Compliance to about \$1,799.

Q How long does it take Doola to form my LLC?

Many founders report their LLC formed within 24 hours of signing up. Total turnaround including the EIN depends on IRS processing times, but Doola moves the paperwork fast and tracks it in your dashboard.

Q What's the best state for a non-resident LLC — Wyoming, Delaware or New Mexico?

For most non-residents, Wyoming wins: low annual fees (~\$60/yr), strong privacy, no state income tax. New Mexico is the cheapest with no annual report. Choose Delaware mainly if you'll raise venture capital or convert to a C-Corp.

Q What taxes does a foreign-owned US LLC have to file?

A foreign-owned single-member LLC must file Form 5472 with a pro-forma Form 1120 each year (multi-member LLCs file Form 1065). The deadline is generally April 15, and missing Form 5472 can trigger a \$25,000 IRS penalty. Doola's Total Compliance plan files these for you.

Q Does Doola offer a refund or money-back guarantee?

Yes — a 60-day money-back guarantee on its service fee. State filing fees paid to the government are non-refundable, and refunds generally don't apply once an application has been submitted to a state or agency.

Q Does Doola work for Amazon and Shopify ecommerce or dropshipping?

Yes. You can connect Shopify or Amazon to the Doola dashboard and your store, order and product data syncs automatically — great for clean bookkeeping. Paired with a US LLC and bank account, you can accept Stripe and sell to US customers.

Q Do I have to travel to the US to use Doola?

No. The entire process — formation, EIN, US address and bank account setup — is handled 100% remotely from anywhere in the world.
