

Doola LLC Formation: An Honest Review for First-Time Founders

I formed my first US LLC with Doola from outside the States — EIN without an SSN, a US bank account, bookkeeping and taxes. Here's my honest take, the real pricing, and how to grab 10% off.

MY RATING

For a first-time founder, Doola was worth it

Doola nailed the scary parts — getting an EIN without an SSN, opening a US bank account remotely, and the yearly IRS filings I'd never have figured out alone — and it did it fast, forming my LLC within about a day. It isn't the cheapest and the dashboard is plain, but for a beginner it removed almost all the guesswork.

MY QUICK TAKE

What Is Doola, and Is It Right for a Beginner?

When I started out as a freelancer outside the US, I hit the same wall most beginners do: I wanted a US LLC so I could accept Stripe, invoice in dollars and look legit to American customers — but I had no SSN, no US address, and no clue how the IRS worked. **That gap is exactly what Doola exists to close.**

For one yearly subscription, Doola registers your LLC (usually in Wyoming or Delaware), gets your **EIN from the IRS without needing an SSN or ITIN**, sets up a US business address and registered agent, drafts your operating agreement, and guides you through opening a real US bank account remotely via Mercury or Relay. The higher tier also covers your bookkeeping and yearly federal tax return.

Lawyers used to charge **\$2,000–\$5,000** for this exact work. Doola rolls it into a simple sign-up flow that's often finished inside 24 hours — the least painful route I've found for a first-time international founder.

What You Actually Get for Your Money

1 LLC & C-Corp Formation

All the registration paperwork filed in beginner-friendly states like Wyoming or Delaware — you fill out nothing.

2 EIN Without an SSN

The part that sold me: your IRS Employer ID secured even with no SSN or ITIN — the wall that stops most first-timers, gone.

3 Registered Agent

A full year of registered agent, so your company always has a compliant US contact on record.

4 US Business Address

A genuine US address — handy for banking, Stripe and looking established to customers.

5 US Bank Account, Remotely

Guided setup with Mercury or Relay — take Stripe payments and bill in dollars without a flight.

6 Operating Agreement

A ready-made operating agreement — the document banks keep asking new founders for.

7 Bookkeeping & Tax Filing

On Total Compliance: bookkeeping plus your annual filing — Form 5472 + 1120, or 1065.

8 BOI / FinCEN & Reminders

Beneficial-ownership reporting under the Corporate Transparency Act, with quarterly reminders.

The LLC is filed and your EIN request goes to the IRS — no SSN needed from you.

3

Open your US bank

Follow the guided steps to open a Mercury or Relay account remotely and hook up Stripe.

4

Stay compliant

On Total Compliance, Doola keeps the books and files the taxes, so you get back to work.

DOOLA FAQ

Quick Answers Before You Sign Up

Q Is Doola legit, or a scam?

Legit. Doola (operated by Distributed, Inc.) launched in 2020, is based in New York, and holds a 4.7-star Trustpilot score from 2,000+ reviews. I had no trust issues.

Q Can a first-timer get an EIN without an SSN?

Yes — the whole reason I picked Doola. They file the EIN with the IRS for you even with no SSN or ITIN.

Q What does it cost?

Starter \$297/yr, Total Compliance \$1,999/yr, plus state fees. With my link the 10% comes off automatically at checkout.

Q How long did formation take?

My paperwork was done in about a day. The EIN runs on the IRS's timeline (a few weeks for non-residents), but Doola files and chases it.

Q Do I need an ITIN?

No — you can form the LLC, get the EIN and open most US bank accounts without one.

Q Best state for a beginner?

Usually Wyoming (cheap, private, no state income tax). New Mexico is cheapest; Delaware mainly if you'll raise VC.

Q What taxes will my LLC owe?

A foreign-owned single-member LLC files Form 5472 + a pro-forma 1120 yearly (1065 if multi-owner). Missing 5472 risks a \$25,000 penalty — Total Compliance handles it.

Q Do I have to fly to the US?

No — formation, EIN, address and bank account are 100% remote. I did it all from home.

Q How do I get the 10% discount?
