



Simplify Your Arrival into Orlando International Airport – Introducing Mobile Passport Control App

Mobile Passport Control (MPC) allows eligible travelers to submit their travel document, photo, and customs declaration information through a **free**, secure app on their smartphone or other mobile device.

HOW MPC WORKS



Visa Waiver Program
Country travelers can use MPC only after they have previously entered the U.S.



Travelers select "U.S. Airport" and then select their arrival airport.



Download the app from the Apple App Store or Google Play Store.



Submit a self-photo and answer a series of Custom and Border Protection questions and declaration form.



Eligible travelers will be prompted to create a profile with their passport or Lawful Permanent Resident card information.



Travelers will then bring their physical passport to a CBP officer to finalize their entry into the United States.

THINGS FOR TRAVELERS TO KNOW



MPC users will be directed to designated processing lanes for a streamlined entry process by a CBP officer.



The app allows up to 12 family member profiles to submit one MPC transaction, including answers to the CBP inspection questions.



Must present a valid U.S. Passport, U.S. lawful permanent resident card, Canadian passport or passport issued by a Visa Waiver Program country to a CBP officer upon arrival.



Cell phones are permitted in the Federal Inspection Station (FIS) for MPC usage *only*. Photography/video or audio recording of the inspection area is prohibited. *Orlando International Airport offers complimentary wi-fi in the FIS.*

The MPC mobile app, is available to U.S. citizens, U.S. lawful permanent residents, Canadian B1/B2 citizen visitors and returning Visa Waiver Program travelers with approved ESTA. MPC is currently available at 33 U.S. International Airports, 13 Preclearance locations, and 4 seaports of entry.

The Visa Waiver Program (VWP) permits citizens of participating countries to travel to the United States for business or tourism for stays of up to 90 days without a visa. Below are the 42 countries participating in the Visa Waiver Program:
