

“TIM AND TAM DAY” PROMOTION
FULL TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

Eligibility Criteria

2. Entry is only open to New Zealand residents aged 16 years or over whose first names begin with the consecutive letters “T-I-M” or “T-A-M”. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Winner Determination & Prizes

The judging panel will determine the winners based on eligibility and order of entry. The decision of the judging panel will be made in its sole and absolute discretion.

12. Once a submission has been validated, winners will receive their prize through postal delivery or similar service to the address specified in the entry process. The prize will be fulfilled within 6-8 weeks of submission.
13. Once the allocated number of eligible entries have been received, the promotion will end.
14. The first 1,000 eligible entries will be deemed winners and each will receive three (3) packs of Tim Tam chocolate biscuits (valued at NZD \$11.40).
