Short Response:

- 9. How did Daniel maintain his faith while in Babylon? Daniel maintained his faith by refusing to eat the king's food, which was part of pagan rituals. Instead, he ate only vegetables and drank water to stay in favor with God. Daniel could have taken the easy path and eaten like a king, but instead, he trusted in God's outcome. He stayed committed to God, and God took care of him. Daniel did not compromise his faith even though he was afraid.
- 10. Why did Daniel break the law? What does Daniel's decision to break the law despite serious consequences demonstrate about his character? Daniel broke the law because the king's law went against God's law. Daniel was very committed to praying and prayed to God three times a day. Although he knew there would be consequences, Daniel was more concerned about serving God. This demonstrates that Daniel was very faithful to God. Daniel trusted that his life was always in God's hands, and he counted on that, even when they locked him in with the hungry lions.
- 11. Why was Daniel thrown into the lion's den, and how did he survive? Daniel was thrown into the lion's den because he continued to pray to God despite a law that forbade it. He survived because God sent an angel to shut the lions' mouths and protect him.

Making Connections:

12. What does Daniel's experience in the lion's den demonstrate about his character, and what lesson(s) can be drawn from this?

Sample answer: Daniel's experience in the lion's den demonstrates his bold courage and unwavering faith in God. We can learn that staying committed to our faith and doing what we believe is right, even when it is difficult, can lead to protection and support from God. Once again, because Daniel did not compromise his faith and he stayed fully committed to God, God protected him from harm.

13. What does Daniel's story teach you about the value of faith and courage in overcoming challenges? Give a specific example of how you can apply this lesson to your own life and explain.

Sample answer: Daniel's story teaches that having faith in God and being brave can help me get through tough times. For example, when I was nervous about joining the school play, I remembered how Daniel trusted God even when facing lions. It helped me be brave and try out for the play, and I ended up making new friends and having fun!
