## **PRISM Data Use Agreement**

I request access to data collected by the Parkinson's Real World Impact assesSMent (PRISM) study for the purpose of scientific investigation, teaching, or the planning of clinical research studies and agree to the following terms:

- 1. I will receive de-identified data and will not attempt to establish the identity of or attempt to contact any of the PRISM subjects.
- 2. I will not further disclose these data beyond the uses outlined in this agreement and my data use application.
- 3. I will require anyone on my team who utilizes these data or anyone with whom I share these data to comply with this Data Use Agreement by registering in the PRISM database and agreeing to these terms.
- 4. I will accurately provide, if solicited, information about the analyses that are planned using these data.
- 5. I will respond promptly and accurately to requests to update this information.
- 6. I will comply with any rules and regulations imposed by my institution and its institutional review board in requesting these data.
- 7. I will comply with the following PRISM Intellectual Property (IP) Policy that states:
  - a. Rights to any non-PRISM IP ("Background IP") that a researcher uses in analysing or manipulating PRISM data, information, materials, or results ("Study Materials") may not be claimed by any other researcher or institution;
  - b. No researcher or institution may claim any IP rights to any Study Materials or inventions arising out of the Study Materials; and,
  - c. Researchers who publish or present analyses of Study Materials will make these freely available without charge to the research community through the PRISM website, when not prohibited by journal copyright terms and conditions.
- 8. If I seek to publish manuscripts using data from PRISM, I agree to follow the guidelines established and written out in the PRISM Publications Policy, including sending published manuscripts and full citation to PRISM study leadership (comprising BIAL and the PRISM steering committee).
- 9. In manuscripts utilizing PRISM data, I will acknowledge the work by the PRISM steering committee members, as well as funding of the study, and will include language in manuscripts similar to the following:
  - a. "Data used in the preparation of this article were obtained from the Parkinson's Real World Impact assesSMent (PRISM) database (www.prism.bial.com)."
  - b. "PRISM study and database was funded by BIAL Portela & Ca, S.A., designed in collaboration with The Cure Parkinson's Trust, an advocacy group based in the United Kingdom (UK), and reviewed by the PRISM steering committee."
- 10. To promote further scholarly productivity, I acknowledge that PRISM study leadership may request that I submit data generated from analyses of PRISM data upon completion of my

- analyses. I understand that PRISM study leadership may choose to incorporate raw data into the PRISM database after its publication.
- 11. In an effort to support and promote work utilizing PRISM data, I will endeavour to upload abstracts of publications to the PRISM website, in addition to point 7.c.
- 12. I will do my best to ensure that Investigators who utilize PRISM data use appropriate administrative, physical, and technical safeguards to prevent use or disclosure of the data other than as provided for by this Agreement and will promptly report any use or disclosure of data that does not comply with the guidelines established by this Agreement.
