PRISM Publications Policy

Introduction

Parkinson's Real World Impact assesSMent (PRISM) database is provided by the sponsor BIAL, designed in collaboration with The Cure Parkinson's Trust, an advocacy group based in the United Kingdom (UK), and reviewed by the PRISM steering committee. The database originated from a pan-European survey of the burden of Parkinson's disease (PD), medication use, healthcare resource utilisation (HCRU) and health-related quality of life (HRQoL) of people with Parkinson's (PWP) and their care partners.

This document outlines the policies for publication and authorship credit for all manuscripts, abstracts, and posters utilizing PRISM data.

Publications Policy

The intent of this policy is to ensure that:

- PRISM data is published fully, accurately, and expeditiously
- PRISM steering committee members and sponsor are recognized for their effort in study design, acquisition, and analysis of data
- PRISM publications may be tracked to develop a complete record of the findings resulting from PRISM efforts
- PRISM publications are open and available to the public free of charge, when not prohibited by journal copyright terms and conditions.

Guidelines for all Manuscripts

As per the PRISM Data Use Agreement, investigators are reminded that they must use PRISM database to generate meaningful publication with added value to the scientific community.

Previous submission of all manuscripts and abstracts to PRISM steering committee review will **not** be necessary.

All publications using PRISM data must acknowledge the steering committee and funding support by including the following within the manuscript or acknowledgements:

- "Data used in the preparation of this article were obtained from the Parkinson's Real World Impact assesSMent (PRISM) database (www.prism.bial.com)."
- "PRISM study and database was funded by BIAL Portela & Ca, S.A., designed in collaboration with The Cure Parkinson's Trust, an advocacy group based in the United Kingdom (UK), and reviewed by the PRISM steering committee"

Overall study methods are described in the following manuscript (Tolosa, E et al. The Parkinson's Real World Impact Assessment (PRISM) Study: A European Survey of the Burden of Parkinson's Disease in Patients and Their Carers. *J Parkinsons Dis.* 2021 May 19. doi: 10.3233/JPD-212611), that must be cited in all published manuscripts or abstracts using PRISM data. Additional methodology should be tailored to the analyses presented.

Full citation of all published manuscripts will be provided to PRISM study leadership (BIAL and the PRISM steering committee) upon acceptance of manuscripts. A copy of the manuscript will be provided to PRISM study leadership upon publication of the manuscript so that it may be listed on PRISM website, when not prohibited by journal copyright terms and conditions.

External users of PRISM data are strongly encouraged to publish results in open-access journals or in a hybrid open access journal as a fully open access article, and/or post to open repositories.
