

Disbursements

Disbursements are the costs of necessary services provided by third party specialists in order to provide our grant of representation and estate administration service.

The costs of disbursements are charged in addition to the fixed fee for our grant of representation and estate administration service. These are set out below.

1. Standard disbursements

These are always required to provide our grant of representation and estate administration service.
