

These terms and conditions (the “Terms”) apply to all application(s) made through the Expo Dubai Group FZCO website (the “Website”) to submit a project in consideration of Expo Live.

**BY SUBMITTING A PROJECT AS STATED ABOVE YOU AGREE TO  
AND ACKNOWLEDGE THE BELOW:**

Expo Dubai Group FZCO is a Free Zone Company registered at the Expo City Dubai Authority (license number EXR-0001). Reference to Expo Dubai Group FZCO in these Terms shall include its owner, affiliates, partnerships, associated organizations, establishments or other related governmental bodies, mainly (without limitation) Expo City Dubai Authority. Expo Live is an Expo Dubai Group FZCO initiative to provide applicants the opportunity to apply, via the Website, for funding for innovative projects (the “Project”) in accordance with these Terms. Expo Live funding is open to eligible individuals or organizations as stipulated in the Grant Manual, other than directors or employees of Expo Dubai Group FZCO or anyone else involved in the organizing of the Expo Live Fund or the judging of any Projects. The Projects considered suitable for funding are set out in detail in the Expo Live Grant Manual.



## **APPLICATIONS**

Upon submission of a Project through the Website, Expo Dubai Group FZCO will review the Project for its suitability for funding by the Expo Live Fund. The evaluation process and criteria are set out in detail in the Expo Live Grant Manual but are subject to change at Expo Dubai Group FZCO's sole discretion, and without prior notice to you. Expo Dubai Group FZCO may choose in its sole discretion whether to accept or reject the Project and shall have no obligation to provide any justifications for any acceptances or rejections. The decision of Expo Dubai Group FZCO shall be final, non-challengeable and non-appealable. Expo Dubai Group FZCO shall use reasonable endeavors to reply to each application but in the event that you do not receive a response within ninety (90) days of submission, your application shall be deemed declined. Proof of submitting an entry via the Website is not proof of receipt by Expo Dubai Group FZCO. Successful applications will be notified by Expo Dubai Group FZCO and the approved applicants will be invited to enter into a funding agreement based on Expo Dubai Group FZCO's standard funding terms and conditions (Grant Agreement). The amount of funding depends on the category and type of each Project; this will be decided by Expo Dubai Group FZCO at its sole discretion. There shall be no obligation on Expo Dubai Group FZCO to provide any funding until it has entered into a legal binding Grant Agreement with the successful applicants. The Grant Agreement will set out the terms and conditions of the funding in detail. By applying for Expo Live funding through our Website, you confirm and warrant that all representations and information provided to Expo Dubai Group FZCO are true and accurate. You will be required to submit additional information, documents and qualifications related to the Project as may be requested by Expo Dubai Group FZCO from time to time. Expo Dubai Group FZCO reserves the right to revoke or withdraw any approval or award or funding granted at any time, whether before or after its selection by Expo Dubai Group FZCO, in its sole discretion.

## **LIABILITY**

To the maximum extent permitted by applicable law, under no circumstances shall Expo Dubai Group FZCO be liable for any actual or alleged loss of profits or revenues, anticipated profits or revenues, savings, business or opportunity or loss of publicity or loss of reputation or opportunity to enhance reputation or any other sort of economic loss whatsoever or, without prejudice to the foregoing, for any indirect or consequential loss, where such aforementioned losses arise by way of any claim for damages hereunder or otherwise.

You acknowledge that all intellectual property rights together with all other rights, title and interest in and to Expo Dubai Group FZCO and the Expo Live Programme are owned by and vested absolutely in Expo Dubai Group FZCO and/or its licensors. These Terms shall be governed by and construed in accordance with the federal laws of the United Arab Emirates and the local laws and regulations as applicable in the Emirate of Dubai.
