# 1. Eligibility

- 1.3. ECD reserves the right at any time to request information from the winner(s) to verify compliance with the Eligibility Criteria, Conditions and Restrictions or award the Prize.
- 1.4. ECD reserves the right to:
  - i. disregard or disqualify a) late, misdirected, incomplete, corrupted, lost, illegible or invalid entries; or b) entrants whose conduct may bring ECD (or its affiliates) into disrepute (as ECD may decide in its discretion).
  - ii. modify (including by adding additional rounds), suspend, cancel or terminate the Competition or extend or resume the entry period or disqualify any Participant at any time without giving advance notice and will do so if it cannot be guaranteed that the Competition can be carried out fairly or correctly for technical, legal or other reasons (including any printing or communication error) or if ECD suspects that any person has been manipulating entries or the results, or has provided false information or has acted unethically in any other way.

## 2. Winner(s) selection

- 2.1. ECD reserves the right to ask the winner(s) to sign a written release, request proof of identity and/or verify the entry before awarding the Prize.
- 2.2. ECD's decision to select any winner(s) or runner-up is final and we reserve the right not to correspond on any matter.
- 2.3. If more than three Participant achieves the same value in relation to the Eligibility Criteria and Conditions, such that all such Participants might reasonably have achieved equal status as a potential 'winner(s)', ECD reserves the right to add additional stages, criteria or conditions to the Competition in order to establish the three overall winner(s).
- 2.4. If at any time (i) we require a response from the winner(s) before awarding any Prize and no response is received after we have made reasonable efforts to make contact and within a reasonable period of time (or by the dates set out above), or (ii) the winner(s) declines to accept the Prize; or (iii) the required documentation for transfer of the Prize is not received by ECD in time; or (iv) the winner(s) becomes unavailable; or (v) it is not possible for the winner(s) to collect the Prize, ECD reserves the right to withdraw the Prize entitlement.

### 3. Prize Collection

- 3.2. - 4.2. - 5.1. ECD has arranged this Competition in good faith but, to the fullest extent allowed by law, accepts no responsibility for loss or damages as a result of anyone participating in the Competition or any aspect of any Prize awarded.
- 5.2. The winner(s) bears sole responsibility for all additional costs and expenses associated with claiming the Prize, including any taxes, registration fees, insurance, maintenance, charges and other expenses related to the Prize (if applicable).

- 6.3. In the event any disputes arise, disputes will be subject to the jurisdiction of the Dubai Courts, with the laws of Dubai as the governing rules.
