

rova - “rova Relax and Recharge”

By entering into this rova Relax and Recharge promotion (the **Promotion**), you agree to all of these terms and conditions.

Promotion Details

Entry Period

- Entry opens on 10 June 2026 at 8:00 am and closes on 13 June 2026 at 4:00 pm (**Entry Period**).
- The winner will be announced on 19 June 2026.

How to Enter

On-site activation

- Entry is via on-site activation.
- To be eligible for the Prize, entrants must take part in the rova Relax and Recharge activation at the rova site (PC51 and PD52) at Fieldays located at 125 Mystery Creek Road, Hamilton 3240 between:
 - 8:00 am - 5:00 pm on 10, 11 and 12 June 2026; and
 - 8:00 am - 4:00 pm on 13 June 2026.
- Entrants will be required to scan their rova pass with one of the rova team members or at the kiosk.¹
- Entrants may enter once per hour via this entry method during the Entry Period.
- Entrants must comply with any and all rules and directions of the Promoter while attending the on-site activation.²

Winner Selection

- All eligible entries will go into a prize draw that will be drawn by rova on 19 June 2026 at 10:00 am.
- The prize draw winner will be phoned by 11:00 am that same day.

- Goods prize conditions include (but are not limited to):

Delivery of the Goods prize

- Hot Spring Spa will liaise directly with the prize winner for the delivery of the prize. The winner agrees that their details will be passed on by the Promoter to Hot Spring Spa for the purposes of facilitating and providing the prize.
- Standard delivery is included at no additional charge, provided the delivery location is within a 50km radius of the following Hot Spring New Zealand dealerships: Whangarei, Auckland, Hamilton, Tauranga, Palmerston North, Napier, Hastings, New Plymouth, or Wellington.³
- A delivery address exceeding the distance stated above will need to be arranged between the prize winner and Hot Spring Spa.

Conditions
