

## More FM - “Steal My Standby”

By entering into this Steal My Standby promotion (the **Promotion**), you agree to all of these terms and conditions.

### Promotion Details

#### Entry Period

- Entry opens on 18 May 2026 at 6:00 am and closes on 29 May 2026 at 6:00 am (**Entry Period**).
- The winner will be announced on 29 May 2026 before 10:00 am.

#### How to Enter

##### Website Registrations

- Registrations are via the competition page on Rova (<https://www.rova.nz/>).
- Entrants may register once via the form on the Rova competition page.
- To register for Entry, entrants must fill out the relevant form in full during the Entry Period.

##### Phone Call

- 1x registered participant will be called out per show during the Promotional Period. They'll have a set time limit (set by the announcers) to call the studio back. If done successfully, they will be in the draw for the Major Prize.
