

More FM - “Big Ben Promotion”

By entering into this Big Ben promotion (the **Promotion**), you agree to all of these terms and conditions.

Promotion Details

Entry Period

- Entry opens on Monday, 11 May 2026 at 6:00 am and closes on Friday, 5 June 2026 at 5:00 pm (**Entry Period**).
- The winners will be announced on or before Monday, 15 June 2026.

How to Enter

Website Entry

- Entry is via morefm.rova.nz on the competition webpage.
- Entrants may enter once via the website entry method.
- To be eligible for the Prize, entrants must fill out the relevant entry form in full and submit it during the Entry Period.

Promotion Mechanics

- By entering this Promotion, entrants will have the chance to bring someone from Australia to New Zealand for a long-overdue reunion.
- As part of completing the entry form, entrants will need to provide:
 - the name of the person(s) they'd like to bring home to New Zealand from Australia (the **Nominated Person(s)**);
 - the contact details of the Nominated Person(s);
 - their relationship with the Nominated Person(s);
 - where in New Zealand they'd like to reunite; and
 - who will the entrant and Nominated Person(s) be surprising in New Zealand, and the reason why.
- Entrants must obtain permission from the Nominated Person(s) to enter this Promotion and to be eligible for the Major Prize(s).
- Given the sensitivity of the personal information required as part of this Promotion (as set out above), all entrants acknowledge and agree that:
