



More FM - “Wine, Dine, Unwind”

By entering into this *More FM Wine, Dine, Unwind* Promotion (the **Promotion**), you agree to all of these terms and conditions.

Promotion Details

Promoter

- MediaWorks Radio Limited (company number 4586999).

Promotion Period

- Entry opens on Wednesday, 17 June 2026 at 6:00am and closes on or before Friday, 3 July 2026 at 7:00 pm (**Promotion Period**).
- The winner will be announced during the Promotion Period.

How to Enter

Phone Call

- Entry is via phone call only.
- To be eligible for a prize, entrants must call through on 0800 MORE FM when they hear the “cue-to-call” playing between 6:00 am and 7:00 pm every day during the Promotion Period.
- All entrants brought to air during the ‘Promotion Period’ will automatically receive an entry to go into the random prize draw to win the major prize.
- During the Promotion Period, there may be multiple chances to enter each day. The number of chances to enter each day will be at the Promoter’s absolute discretion and may vary across the Promotion Period.
- Entrants may enter as many times as they like via the phone call entry method.
- Entrants acknowledge that their call may be played live on air, or recorded and played on air at a later time.

Promotion Mechanics & Winner Selection

- All eligible entries will go into a prize draw that will be drawn by More FM on or before Friday, 3 July 2026.
- The major prize draw winner will be phoned live on air before 7 pm.

- If the winner does not pick up the first time that the promoter calls, the promoter will select a new winner and the process will repeat until a winner is found.
- The Promoter may, at its sole discretion, select an alternative winner if:
 - the original entrant has a bad phone line;
 - the call disconnects; or
 - The original entrant does not meet all the Prize Conditions.

Major Prize Details

As part of this Promotion the winner will receive 1 major prize consisting of:

1. Flight prize

- Air New Zealand return flights for 2 passengers from Auckland International Airport, New Zealand to Adelaide Airport, South Australia.
- Travel dates will be five consecutive days between Monday 20 July 2026 and Thursday 10 December 2026, and will be at the sole discretion of the Promoter.¹
- Departure and arrival dates to be within the 'Travel Period' dates, as outlined above
- Included as part of the flight prize is checked-in luggage for each passenger up to 23kg.
- Flight prize conditions include but are not limited to:
 - All unstated costs are specifically excluded from the flight prize.
 - Entrants must hold, or be able to obtain before booking flights, a valid passport (and visa if necessary).
 - Australian and New Zealand passport holders may travel to Australia without obtaining a visa in advance.

 - The Entrant's nominated travelling partner (where there is more than one flight ticket included in the prize) must be 18 years and older, or if younger, have their parent(s) or guardian(s) permission to travel with the Entrant.

2. Cash prize

- \$1,000.00 (NZD) cash deposited into the winner bank account within 14 working days from the date the Promoter receives the winner's bank account.

3. Accommodation prize

- A minimum of five (5) nights accommodation for 2 guests as outlined below:
 - 3 nights accommodation at a minimum four star hotel in Adelaide, Australia
 - 2 nights accommodation at a minimum four star hotel in the Barossa Valley, Australia
 - Check in and check out dates will align with the prize travel dates
 - Rooms will be double standard rooms, based on two people sharing
 - Any fees and/or charges incurred in connection with accommodation above, including hotel fees, deposits, tax, late fees, parking and any other associated fees and charges will be the sole responsibility of the winner.
 - Accommodation is non-transferable.
 - The accommodation prize details will be at the sole discretion of the Promoter

4. Tour prize

- Boutique Barossa Valley Wine Tour for two (2)
 - Approximately 9 hour tour

- Barossa Valley Gourmet Food & Wine E-Bike Tour for two (2)
 - Approximately 6.5 hour guided gourmet food and wine experience, E-bike tour through the Barossa Valley.
 - Small group experience with a maximum of 10 participants
- All tours are subject to availability at the time of booking.
- A minimum 48-hour cancellation notice is required for tour bookings. Cancellation fees may apply for changes or cancellations made within this period.
- The Tour prize details will be at the sole discretion of the Promoter.

5. Rental Car Prize

- 5 day car rental in Adelaide, Australia
- Drivers must present a full, valid driver's licence at the time of collection. If the licence is not in English, a certified translation or International Driving Permit (IDP) may be required.
- The minimum driver age is generally 21 years.
- Drivers under 25 years of age may incur a young driver surcharge. Maximum age restrictions may also apply depending on the rental provider.
- The winner is responsible for all tolls, parking infringements, speeding fines, and other traffic violations incurred during the rental period.
- Any associated administration fees charged by the rental company will also be the responsibility of the winner.

Conditions

 - Travel insurance is not included in this Promotion and will be the sole responsibility of the winning entrant and the nominated travelling partner.
 - The winning entrant and the nominated travelling partner agrees to comply with and be bound by the terms of this Promotion, the Air New Zealand T&Cs, the Accommodation T&Cs and Europcar T&Cs.

Rules

- The Rules that apply to this Promotion are the Specific Rules (being the rules set out above), together with the General Rules.
- By entering into this Promotion, the entrant agrees to the Rules and confirms that they have the necessary authority (for example from the bill payer or owner of a telephone) to enter into the Promotion.

GENERAL RULES

PRIZES

10. MediaWorks reserves the right to substitute the prize(s) for a prize of equivalent or greater monetary value.
