

# The Breeze & Breeze Classic - "Cruise, Fly or Drive - You Choose"

By entering into this Cruise, Fly or Drive - You Choose promotion (the **Promotion**), you agree to all of these terms and conditions.

# **Promotion Details**

## **Entry Period**

- Entry opens on 17 November 2025 at 8:00am and closes on 5 December 2025 at 5:30pm (Entry Period).
- The winner will be announced on 9 December 2025.

#### **How to Enter**

#### Website

- Entry is via https://www.rova.nz/win/cruise-fly-or-drive-you-choose-with-north-travel
- To be eligible for the Prize, entrants must be listening to The Breeze or Breeze Classic at 8:00am, 11:00am, 2:00pm and 5:00pm daily to hear the radio host announce a code word. The code word announced will be different each time.
- When the code word is announced, entrants must go to the competition webpage, complete the entry form in full, and submit it.
- Entry for the given code word is valid for a 30 minute period from the first announcement of that code word live on air at 8:00am, 11:00am, 2:00pm and 5:00pm.
- Entrants may enter once per unique code word via this entry method, which equates to approximately 76 opportunities to enter during the Entry Period.
- Entrants acknowledge that their full name may be read out on air.
- Entrants acknowledge that they may be called to discuss their entry on air.
