

OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

033/OFF/267/2016

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **GENERAL DISTRIBUTORS LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at 1 Vickers Road WAIWHAKAIHO, NEW PLYMOUTH 4312 and known **WOOLWORTHS THE VALLEY**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

This licence is subject to the following conditions:

Conditions

The **OFF LICENCE** be renewed for three (3) years from the date of expiry **10 June 2025**.

No alcohol is to be sold or delivered on **Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day**.

Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday

7:00am to 9:30pm

No alcohol may be sold other than -

- (i) beer that complies with the appropriate New Zealand food standard for beer; or
- (ii) mead that complies with the appropriate New Zealand food standard for mead; or
- (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
- (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
- (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.

The licensed area of the Off Licence for the sale of alcohol is limited to the floor area within the Supermarket as marked on the plan date stamped 22 November 2022.

The only area delineated on the attached plan described in the shading is the permitted single area for the display and promotion of alcohol.

A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.

The **ENTIRE PREMISES** is **UNDESIGNATED**.

Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample on the premises.

The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the sale and supply of alcohol to minors and the complete prohibition on the sales to or intoxicated persons.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence expires on:
