Monday to Sunday 07:00 to 22:00

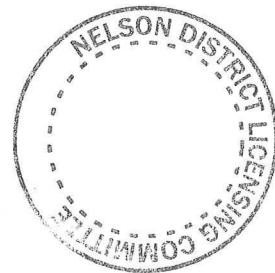
2. WATER – while alcohol is being supplied free as a sample, free drinking water must be provided for customers at the tasting location.

OFF-LICENCE

Sections 17 to 20 and 64 Sale and Supply of Alcohol Act 2012

ARLA Ref: **50/OF/006/2025**
DLC Ref: **OF038**

Pursuant to the Sale and Supply of Alcohol Act 2012 ("the Act"), General Distributors Limited (the licensee) is authorised to sell and supply alcohol on the premises situated at **35 St Vincent Street**, Nelson and known as "**Woolworths Nelson**" to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. **HOURS**
 - a. Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday 7.00 to 22:00
 - b. No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.
2. **WATER** – while alcohol is being supplied free as a sample, free drinking water must be provided for customers at the tasting location.
3. **DESIGNATED AREAS** – The whole of the premises is undesignated
4. **ALCOHOL AREA** – Only the area delineated on the attached plan dated 7 December 2022 is a permitted area for the display and promotion of alcohol.
5. **SIGNAGE** – signage must be displayed at each point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
6. **RESTRICTIONS** – the licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force until the expiry date or if an application for renewal is received before it expires – until 3 years after the expiry date.

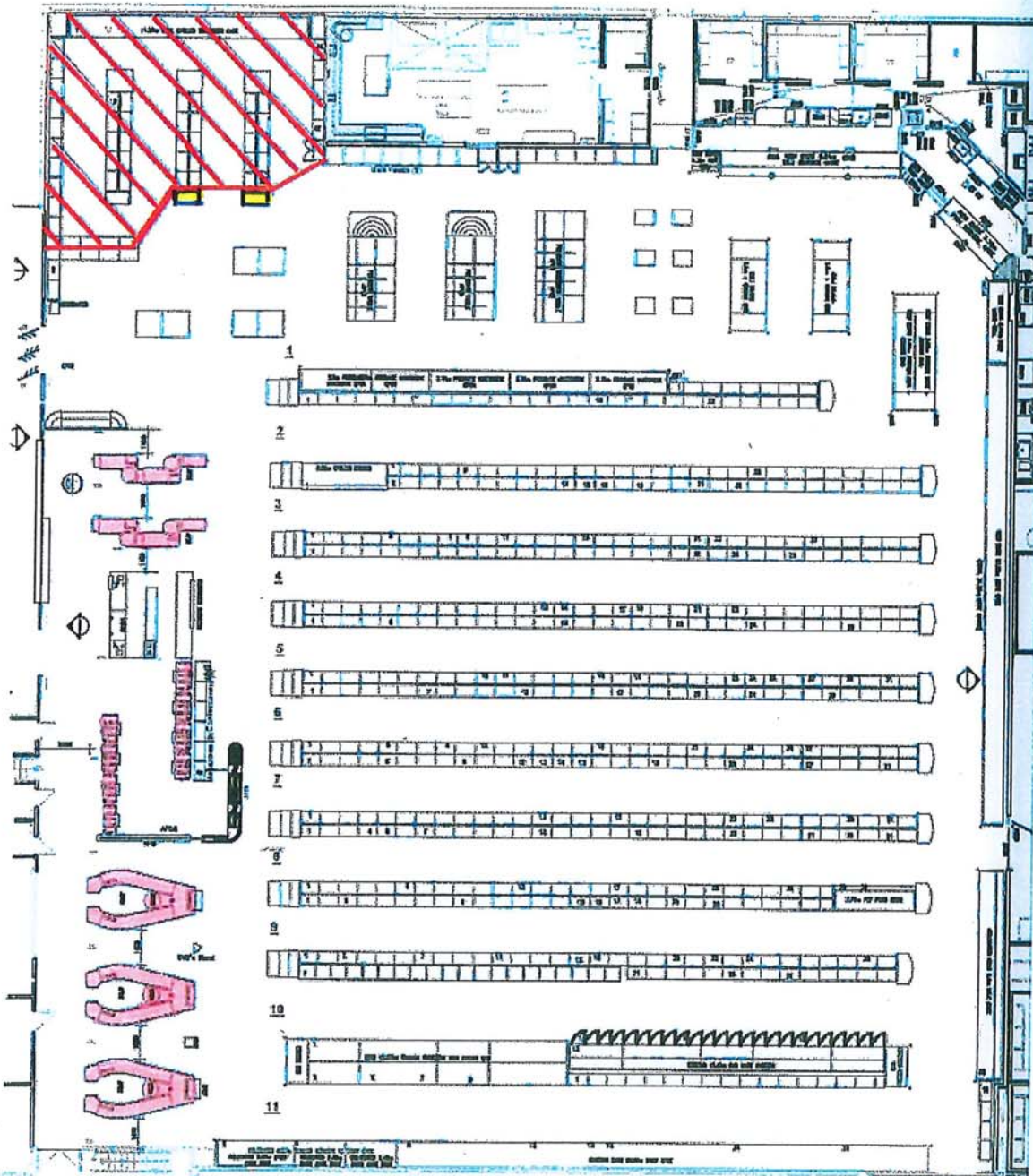
