

Terms and Conditions

Promotional Period

1. The promoter of this promotion is Woolworths New Zealand Ltd, 80 Favona Rd, Favona, Auckland 2024, which owns and operates WWNZ supermarkets (**Promoter**). The provider of the prize for this promotion is Nestlé New Zealand Limited ("Prize Provider")
2. The promotion commences 03/08/26 and closes 24/08/26 (four weeks) (**Promotional Period**).
3. This promotion is open to Everyday Rewards card holders only who are New Zealand residents aged 18 years or older, shopping at WWNZ supermarkets (excluding Metro stores), owned by the Promoter, 80 Favona Rd, Favona, Auckland 2024 ("**Woolworths**"). Please note that employees of the Promoter and Nestlé New Zealand Limited ("**Prize Provider**") cannot be excluded from Everyday Rewards promotions.

Method of Entry

4. For the duration of the Promotional Period, WWNZ customers with an Everyday Rewards card will **enter** the prize draw by either swiping their Everyday Rewards card or entering their Everyday Rewards details at the time of purchase. Entry date for online purchases is the order delivery date (which must be within the Promotional Period). For the avoidance of doubt, customers will not be eligible to participate in this promotion if they do not swipe or enter their Everyday Rewards details at the time of purchase. Entries will not be accepted on a retrospective basis after the time of purchase.
5. Customers can enter by:
