

OFF LICENCE

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

39/OFF/9148/2026

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the Act), **General Distributors Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **520 Pioneer Highway, Highbury, Palmerston North 4412** and known as "**Woolworths Awapuni**", to any person for consumption off the premises and to supply alcohol, free as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

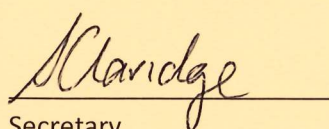
- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day;
- (b) No alcohol is to be sold other than:
 - (1) beer that complies with the appropriate New Zealand food standard for beer; or
 - (2) mead that complies with the appropriate New Zealand food standard for mead; or
 - (3) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - (4) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - (5) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (c) Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday from 7:00AM to 11:00PM
- (d) **The whole of the premises is undesignated.**
- (e) Only the area delineated on the plan submitted on 27 March 2026, is a permitted area for the display and promotion of alcohol.
- (f) Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample.
- (g) A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the carpark from Pioneer Highway is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

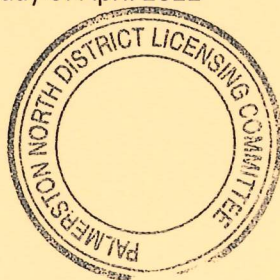
- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

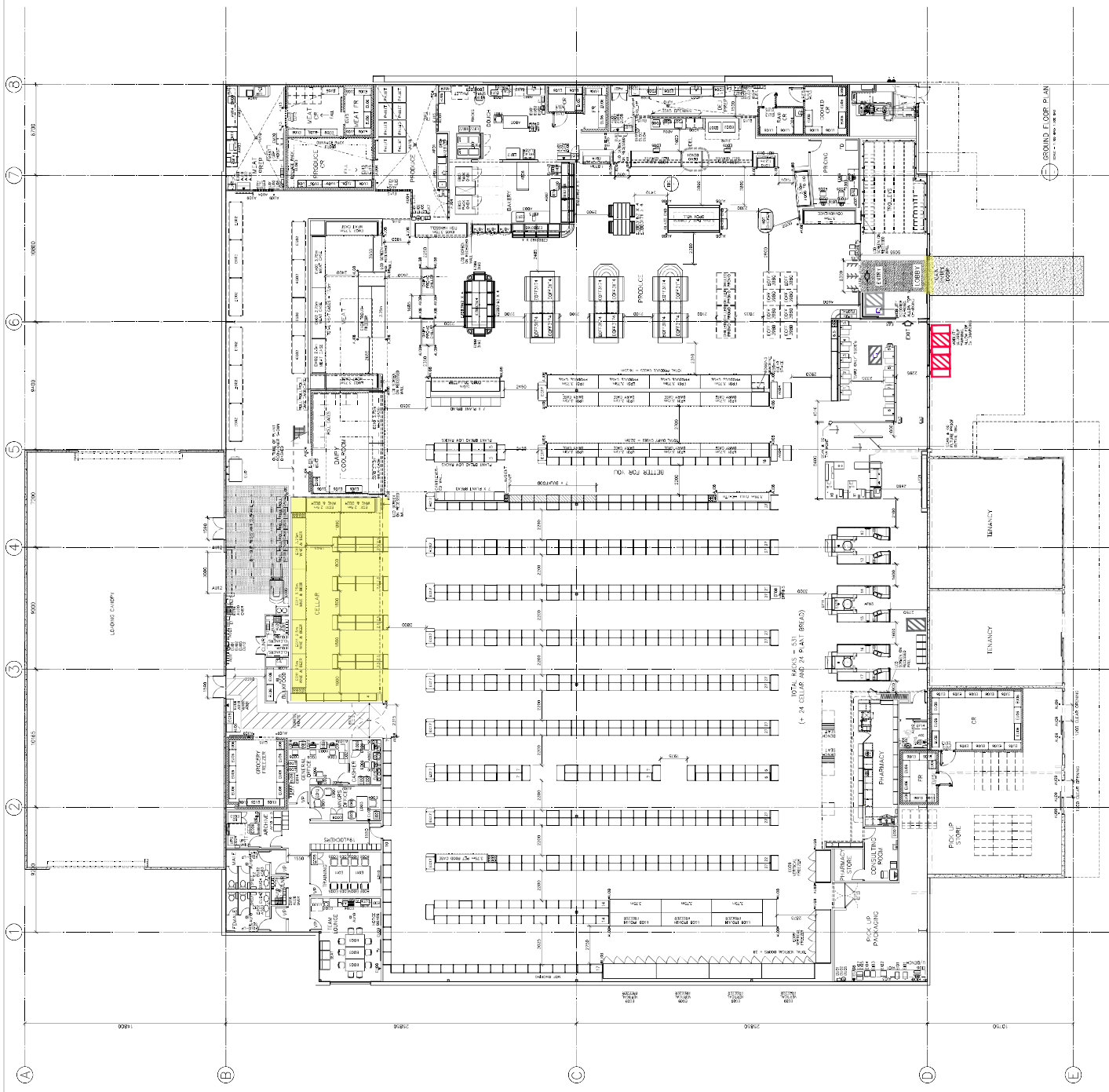
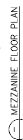
