

OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

033/OFF/113/2015

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **GENERAL DISTRIBUTORS LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at 16 Manadon Street SPOTSWOOD, NEW PLYMOUTH 4310 and known **COUNTDOWN SPOTSWOOD**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

This licence is subject to the following conditions:

Conditions
The OFF LICENCE be renewed for three (3) years from the date of expiry 20 May 2024 .
Alcohol may be sold only on the following days and during the following hours: Monday to Sunday 7:00am to 9:30pm
No alcohol may be sold other than - (i) beer that complies with the appropriate New Zealand food standard for beer; or (ii) mead that complies with the appropriate New Zealand food standard for mead; or (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or grape wine that complies with the appropriate New Zealand food standard for grape wine; or a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
The licensed area of the Off Licence for the sale of alcohol is limited to the floor area within the Supermarket as marked on the plan date stamped 17 APR 2024. The only area delineated as the 'single alcohol area' on the attached plan is a permitted area for the display and promotion of alcohol.
The "Single Alcohol Area" for the premises is as described on the plan and date stamped 17 APR 2024. The licensee must ensure that: a. No alcohol is displayed, promoted, or advertised outside the single alcohol area; and b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted, or advertised inside the single alcohol area.
A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
The ENTIRE SUPERMARKET is UNDESIGNATED .
Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample on the premises.
The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the sale and supply of alcohol to minors and the complete prohibition on the sales to or intoxicated persons.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence expires on:

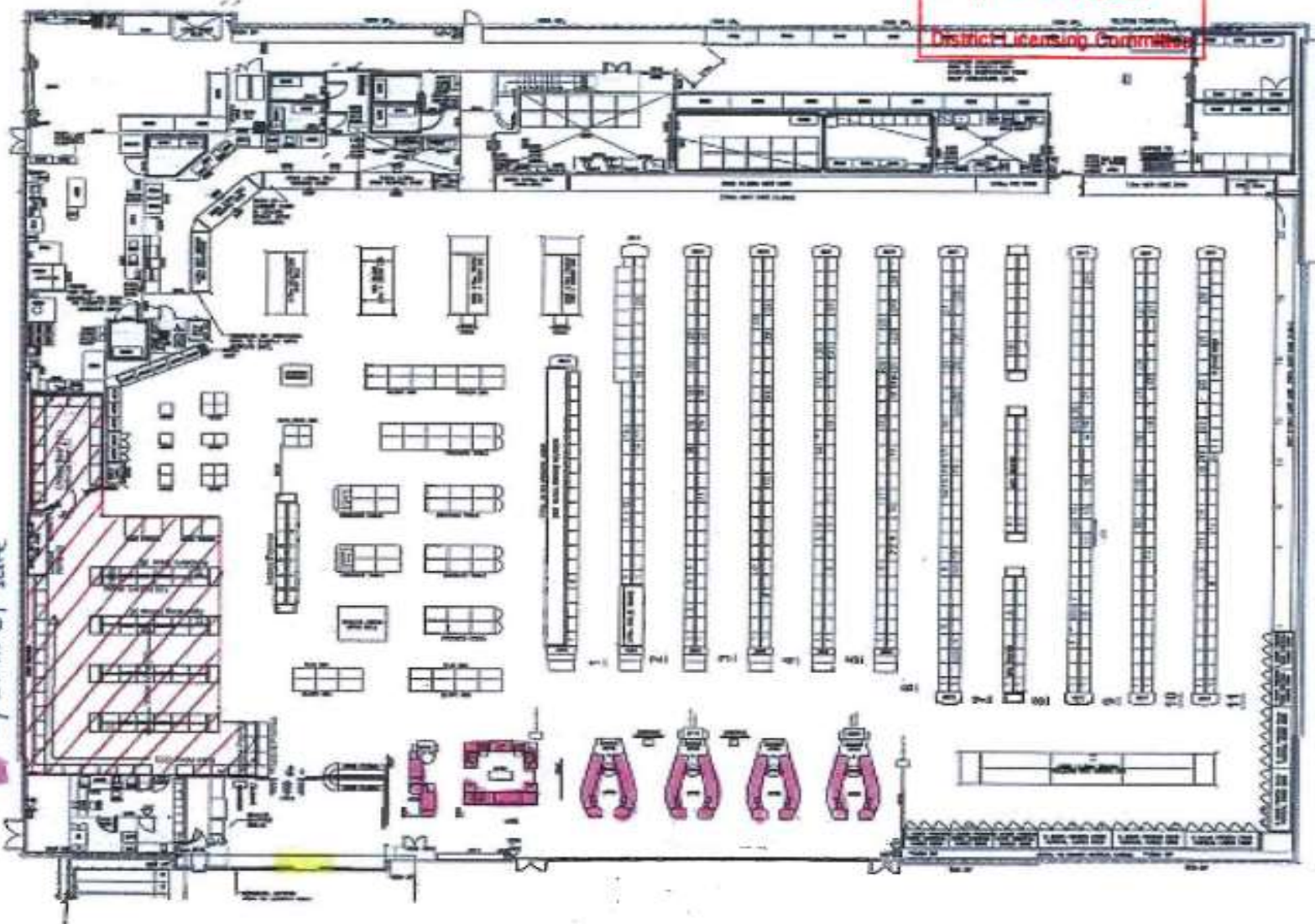
