

Licence No: 30/OFF/0044/2023

PURSUANT to sections 17 to 20, and 64 of the Sale and Supply of Alcohol Act 2012 (the Act), **GENERAL DISTRIBUTORS LIMITED** (the licensee) is authorised to sell alcohol on the premises situated at **139 Station Street Napier South, Napier** and known as **Countdown Napier**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

The licence is subject to the following conditions:

- a. No alcohol is to be sold or delivered on Good Friday, Christmas Day, or before 1pm on Anzac Day.
- b. No alcohol may be sold other than—
 - i. Beer that complies with the appropriate New Zealand food standard for beer; or
 - ii. Mead that complies with the appropriate New Zealand food standard for mead; or
 - iii. Fruit or Vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - iv. Grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - v. A food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- c. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 7.00 am to 10.00 pm

- d. The area outlined in green and hatched in red delineated on the attached plan is the only permitted area for the display, advertisement and promotion of alcohol.
- e. The following steps must be taken by the licensee to ensure that the provisions of this Act relating to the sale of alcohol to prohibited persons are observed:
 - i. Appropriate signs must be prominently displayed adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.
- f. At any time while alcohol is being supplied free as a sample on the premises, drinking water is to be freely available to customers. This must be located and available from the same place at which the free sample is given.
- g. The whole of the premises is undesignated.
- h. The principal entrance for the display of signs and the licence, is the entrance indicated on the plans date stamped as received by the Napier District Licensing Committee on **23rd July 2017**.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the renewal, suspension and cancellation of licences, this licence expires on:

22nd day of July 2026
