

# **OFF-LICENCE RENEWAL**

*Sale and Supply of Alcohol Act 2012 - Section 135*

## **To GENERAL DISTRIBUTORS LIMITED**

The **off-licence** in respect of the premises situated at **144 Salisbury Road, Richmond** and known as **"Woolworths Richmond"** is renewed. Pursuant to the Sale and Supply of Alcohol Act 2012, **GENERAL DISTRIBUTORS LIMITED** is authorised to sell and supply alcohol on the premises to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act. The present conditions of the licence continue to apply. These are as follows:

### **CONDITIONS**

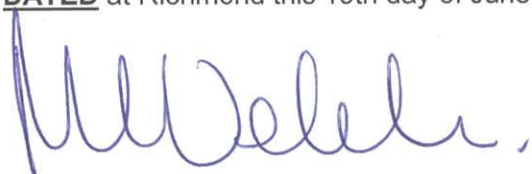
1. **HOURS:** Alcohol may be sold only on the following days and during the following hours:
  - (a) **Monday to Sunday 7.00am to 10.00pm**
  - (b) No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.
2. **RESTRICTIONS:**
  - (a) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.
  - (b) No alcohol may be sold other than—
    - (i) beer that complies with the appropriate New Zealand food standard for beer; or
    - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
    - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
    - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
    - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
  - (c) Only the area delineated on the attached plan is a permitted area for the display and promotion of alcohol. This area will be marked on the floor within the store.
  - (d) The licensee must take reasonable steps to verify that the buyer of any alcohol, sold by remote means, is not under the purchase age.
3. **WATER:** While alcohol is being supplied free as a sample, free drinking water must be provided for customers at the tasting location.
4. **LICENSED AREAS:** The whole of the premises is undesignated. The defined area is the area outlined on the plan received 10 March 2021.
5. **SIGNAGE:** Signage must be displayed at each point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons. The licence holders name, the licence number and the date on which the licence expires must be displayed on any internet site for remote sales, in any catalogue and printed on every receipt issued for alcohol sold remotely.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence expires on

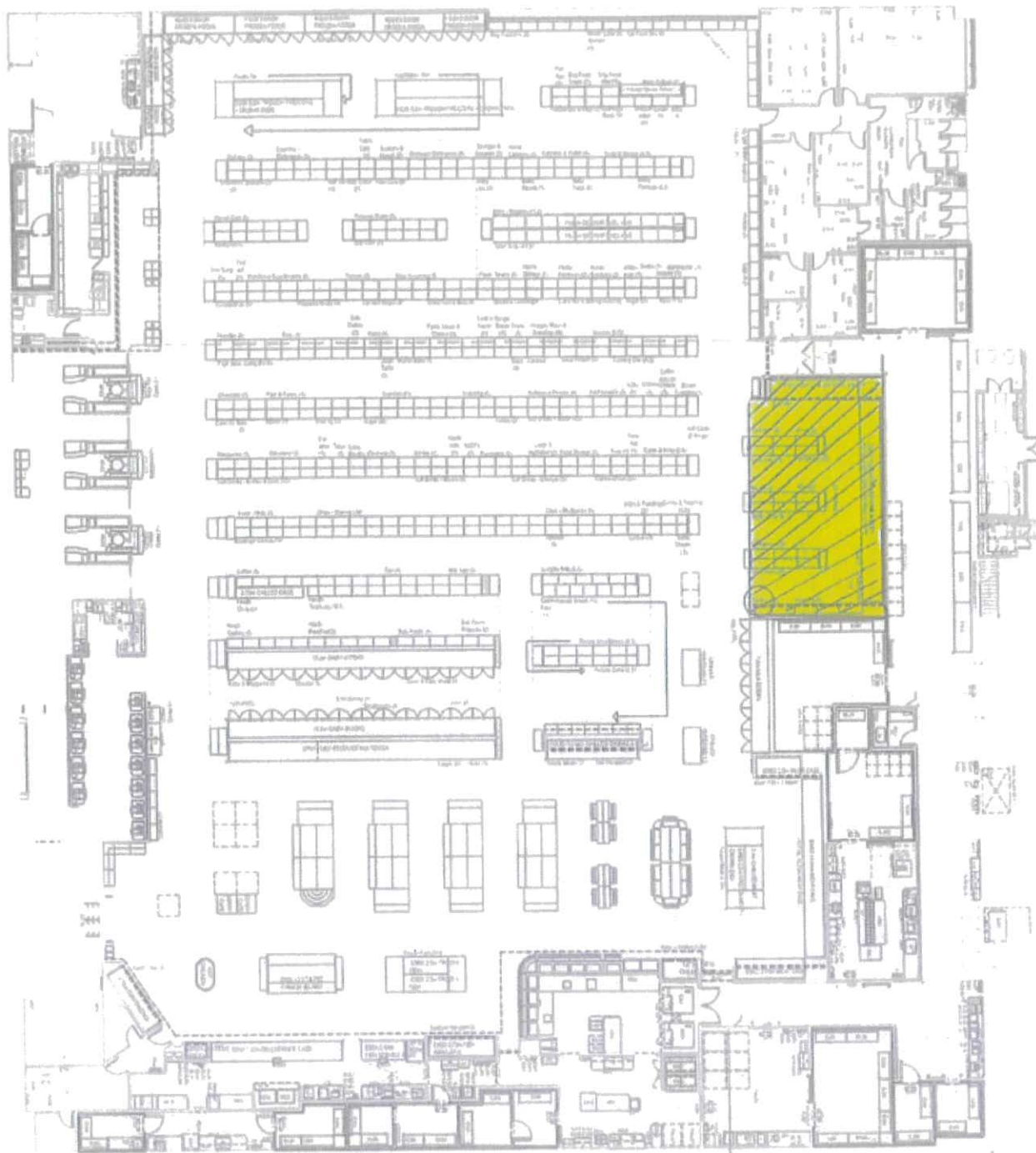
