

Be in to Win a Surf Trip to Tahiti

Promotional Period

1. The promoter of this promotion is Woolworths New Zealand Ltd, 80 Favona Rd, Favona, Auckland 2024, which owns and operates WWNZ supermarkets (**Promoter**). The provider of the prize for this promotion is Farrimond Ltd on behalf of Coca-Cola Europacific Partners New Zealand Ltd (**Prize Provider**). Monster Energy AU Pty Ltd is not the Promoter of the Promotion. The Monster Energy brand names, logos and/or materials are used for the purposes of this Promotion and/or Prize descriptions only and such use is not intended to suggest or imply Monster Energy AU Pty Ltd.'s sponsorship of this Promotion.
2. The promotion commences on 12:00am (NZDT) 27th July 2026 and closes 11:59pm (NZDT) 23rd August 2026 (**Promotional Period**).
3. This promotion is open to New Zealand residents aged 18 years or older who have a registered Everyday Rewards card. Please note that employees of the Promoter and the Prize Provider cannot be excluded from Everyday Rewards promotions, including this promotion.
4. You and your companion must be a New Zealand resident 18+, hold a current and valid passport with a minimum of 6 months' validity at date of travel and be able to redeem the Prize on travel period dates to be confirmed by the Promoter between 1st January 2027 & 31st March 2027 to enter this Promotion.

Method of Entry

5. Customers can enter the promotion, during the Promotional Period by:
 - a. purchasing any 2 (two) Monster Energy 500mL products (all variants included) in 1 (one) transaction or purchasing any 1 (one) x 4 pack of 250mL Monster Energy products (Qualifying Purchase), either in-store or online from a WWNZ supermarket (excluding Metro stores) owned by the Promoter (WWNZ); and
 - b. either swiping their registered Everyday Rewards card or entering their registered Everyday Rewards details at the time of purchase.
6. Entry is limited to one per transaction, regardless of how many Monster Energy products have been purchased within the transaction. Entry date for online purchases is the date of order (which must be within the Promotional Period). For the avoidance of doubt, customers will not be eligible to participate in this promotion if they do not swipe their Everyday Rewards card or enter their Everyday Rewards details at the time of purchase. Entries will not be accepted on a retrospective basis after the time of purchase.
7. Entrants must ensure their Everyday Rewards card is registered with complete and up to date account details (including phone number and email address).

Prize

11. The Prize is a Surf Trip to Tahiti for the Winner and a companion. The Prize is not transferable, redeemable and may not be exchanged for cash. The winner must be available for travel between 1st January & 31st March 2027. Specific travel dates will be determined by the Prize Provider at the time of booking. Flights are from Auckland, New Zealand, only. Winners must make their own way to Auckland to be eligible to take up this prize.
12. The Prize includes:
 - 6 (six) nights’ accommodation in a 4-star hotel in a twin share room (2x single or 1x double bed, subject to availability) (as determined by the Promoter) for the winner and their companion.
 - 2 (two) return economy class flights (including airfare taxes and checked baggage) from Auckland International Airport to Fa'a'a International Airport, Papeete.
 - Return airport to accommodation transfers for two in Papeete.
 - \$2,000NZD spending money for the Winner only.
 - The Promoter will pay all airline taxes, fuel surcharges, levies and ticketing taxes payable at time of booking.
13. Surfing classes, surfing activities and surfing gear/equipment are not included in the Prize. The winner and their companion are solely responsible for all costs associated with surfing lessons, surf coaching, surf guiding, equipment hire, board hire, wetsuit hire, and any other surf-related activities or gear during the trip.
14. Total prize pool estimated value is \$11,500NZD.

Selection of airline, departure times and accommodation venue is at the Promoter’s discretion at the time of booking. Airline travel, airport transfers and accommodation are subject to the relevant supplier’s standard terms and conditions and the Promoter will not be liable for any act or omission of any third party providing those services.
16. If any part of the Prize listed above is unavailable, despite the Promoter’s reasonable endeavours to procure it, the Promoter reserves the right to substitute a different prize of equal or greater value.

Winner(s)

17. The winner will be determined by a random electronic draw from all valid entries received in the promotion on 12pm (NZDT) 24th August 2026. The draw will be conducted by the Promoter.
18. Farrimond Ltd, the Prize Provider's agency, on behalf of the Promoter, will contact the winner. The winner will be notified by telephone and/or email using the details listed on the Everyday Rewards database. It is up to entrants to ensure that their relevant details on their Everyday Rewards account are correct. Prize Conditions
