

OFF-LICENCE
Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012



General Distributors Limited
Licence Number 45/OFF/006/2022

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), General Distributors Limited (the licensee) is authorised to sell alcohol on the premises situated at 6 Ngaio Road, Waikanae and known as Countdown Waikanae, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol is only permitted to be sold, supplied or delivered on or from the premises authorised by the licence.
2. No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
3. No alcohol may be sold other than —
 - (i) beer that complies with the appropriate New Zealand food standard for beer; or
 - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
 - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
4. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday - 7am to 11pm

5. The whole of the premises is **undesignated**.
6. The **single alcohol area** (the only permitted area for the promotion and display of alcohol) is defined on the attached plan, approved on 29 September 2016, and encompasses both sides of aisle one from the checkout end up to and including bay 12, with no outward facing displays of alcohol.
7. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and to intoxicated persons.
8. The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the safe and responsible consumption of alcohol, and minimising alcohol related harm.
9. A copy of this licence must be displayed at the principal entrance, the principal entrance is defined as the entrance from the car park.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

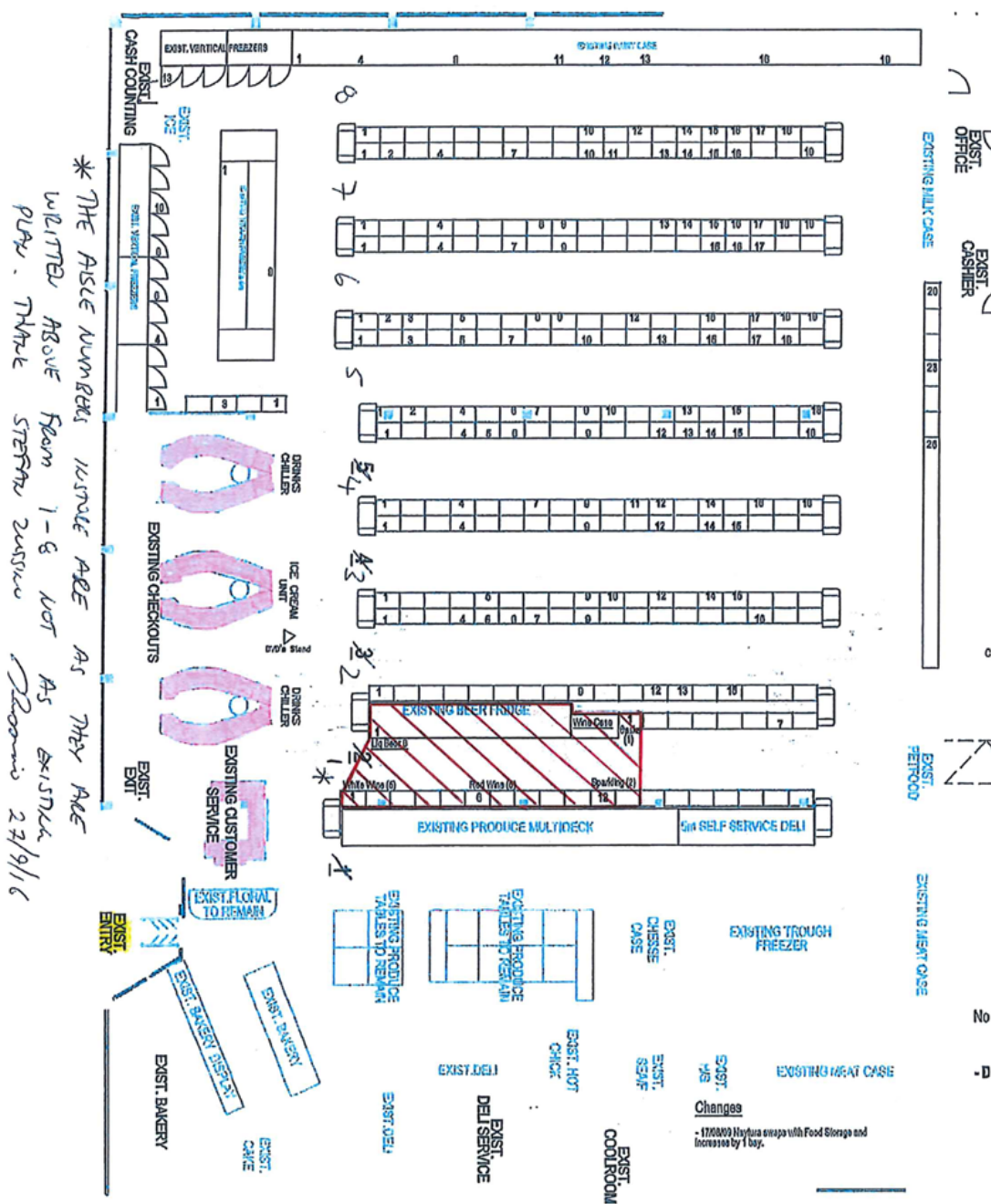
Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, the licence expires on:
