The off-licence in respect of the premises situated at **70 Studholme Street Morrinsville** and known as **Countdown (Morrinsville)** is renewed.

Conditions

The present conditions of the licence are:

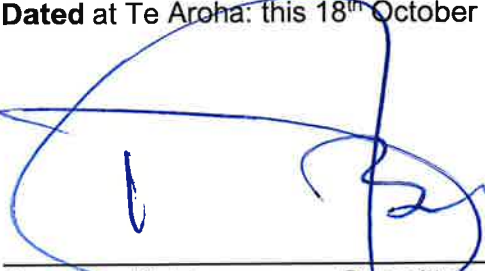
- (a) No alcohol is to be sold or delivered on **Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day**
- (b) No alcohol may be sold other than—
 - (i) beer that complies with the appropriate New Zealand food standard for beer; or
 - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
 - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted
- (c) Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday 07.00 am to 9.00 pm
- (d) The whole of the premises is undesignated
- (e) The area delineated on the attached plan (**CD Morrinsville 9114 14-10-16**) is the only permitted area for the display and promotion of alcohol pursuant to section 112.
- (f) While alcohol is being provided free as a sample drinking water to be provided free from the same location.
- (g) The holder of a Manager's Certificate or a properly notified manager shall be on duty and on the premises at all times alcohol is sold.
- (h) There must be no sale or supply to minors or intoxicated persons and there must be displayed at every point of sale appropriate signs detailing these restrictions.

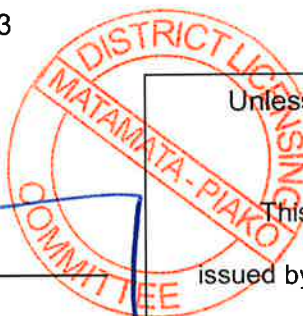
Duration

Subject to the requirements of the Act relating to payment of fees, and to the provisions of the Act relating to suspension and cancellation of licences, this licence continues in force—

- a) until its expiry date detailed below; but
- b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the expiry date.

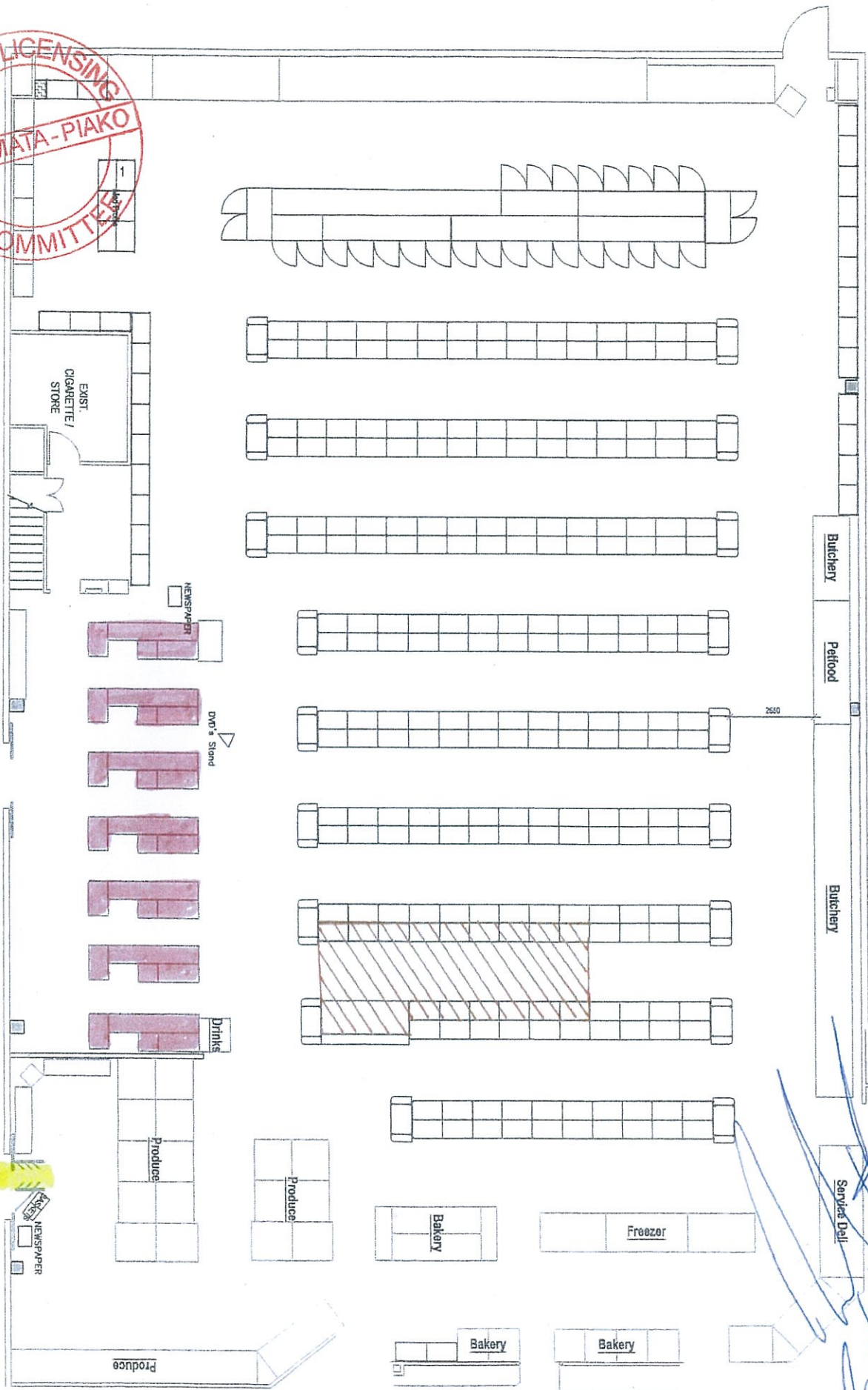
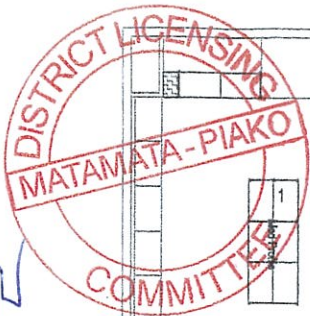
