

OFF-LICENCE

Sections 17 and 64

Pursuant to the Sale and Supply of Alcohol Act (the Act), **GENERAL DISTRIBUTORS LIMITED** (the licensee) is authorised to sell and supply alcohol, on the premises situated at **17 Chappie Place, Christchurch**, and known as "**COUNTDOWN HORNBY**", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

- a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1pm on Anzac Day.
- b) Alcohol may only be sold or delivered on the following days and during the following hours:
MONDAY TO SUNDAY 7.00 AM TO 11.00 PM
- c) Water must be freely available to customers, while alcohol is being supplied free as a sample on the premises.
- d) **Single Area Condition: Alcohol Area for display and promotion of alcohol**
 - Only the area described and delineated on the plan approved by the District Licensing Committee is the permitted area for the display and promotion of alcohol within the premises as required under section 112.
- e) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - i) Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons
- f) The following steps must be taken to ensure that the provisions of the Act relating to the management of the premises concerned are observed:
 - i) Alcohol must only be sold and supplied on the premises in accordance with the premises plan submitted with the application.
 - ii) The licensee must implement and maintain the steps proposed in their host responsibility policy.

SECTION 117 – OTHER DISCRETIONARY CONDITIONS

- a) A certified managers certificate holder will be present in or around the checkout area at all times alcohol is being sold unless there are exceptional circumstances, in which case a replacement certified managers certificate holder must be present in his or her place as soon as practicable.

OTHER RESTRICTIONS AND REQUIREMENTS TO BE NOTED ON THE LICENCE

Section 56 – Display of signs; Section 57 – Display of licences; Section 58 – Restrictions on kinds of alcohol sold in supermarkets and grocery shops, and premises directly accessible from supermarket or grocery shop; Section 59 – Requirements relating to remote sales by holders of off-licences; Section 214 – Manager to be on duty at all times and responsible for compliance

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

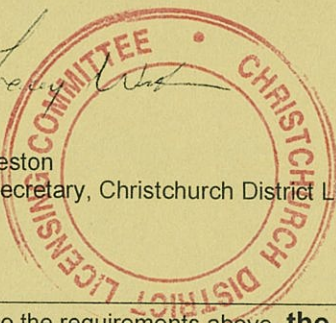
- a) either—
 - i) until the close of the period for which it was last renewed; or
 - ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - i) until the close of the period of 3 years after the period for which it was last renewed; or
 - ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

THE LICENCED PREMISES

The premises are identified on the plan provided with the application for a licence.

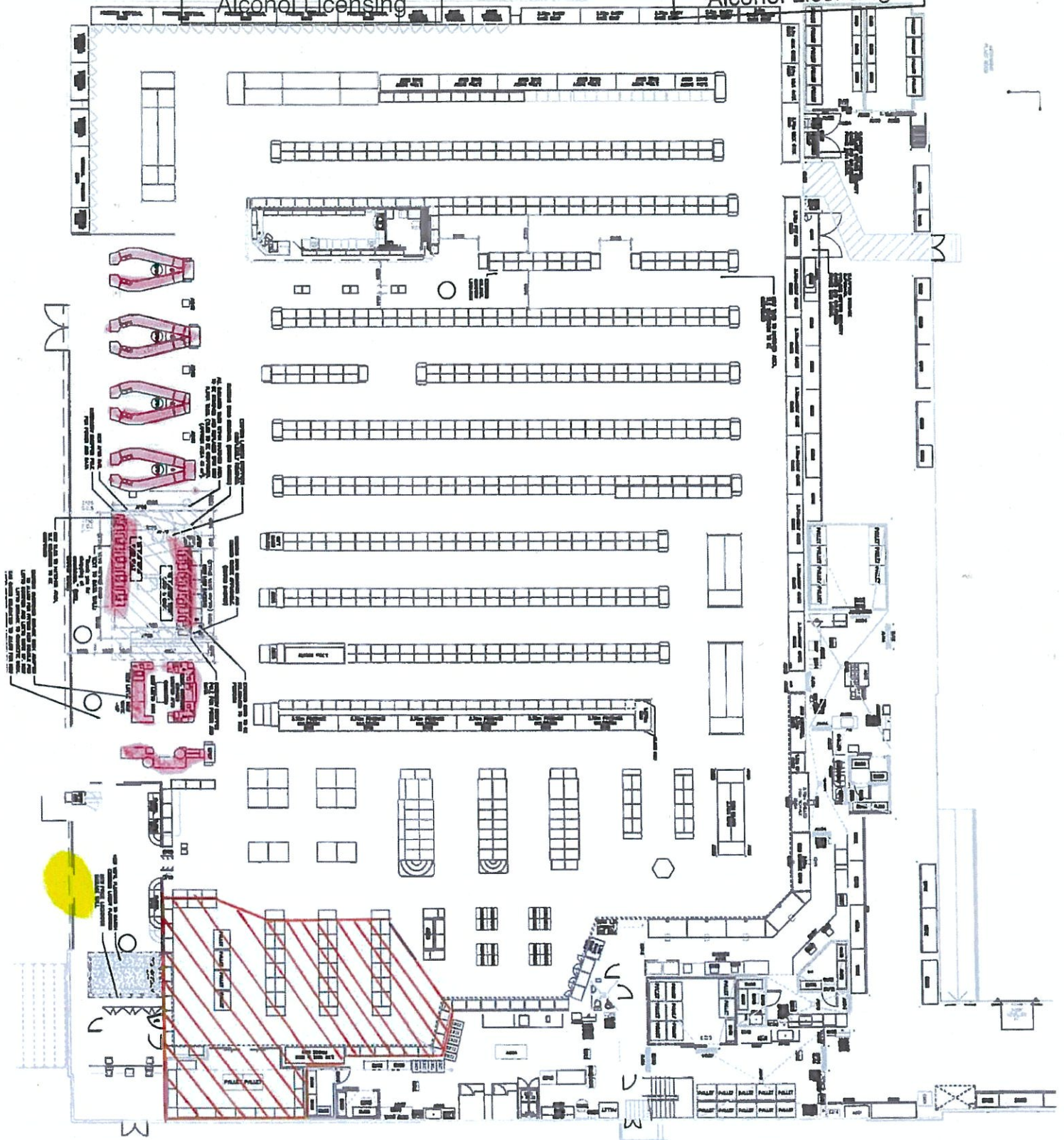

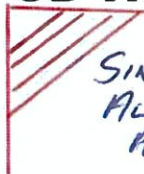
