Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act) **General Distributors Limited** (the licensee) is authorised to sell and supply alcohol on the premises situated at **59 Ardmore Street, Wānaka** and known as **Woolworths Wanaka Metro** to any person for consumption on off the premises, and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day;
- b) No alcohol may be sold other than -
 - i) beer that complies with the appropriate New Zealand food standard for beer; or
 - ii) mead that complies with the appropriate New Zealand food standard for mead; or
 - iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
 - iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
 - v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- c) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 7.00am to 9.00pm

- d) The only area delineated on the plan dated 5 November 2021, is the only permitted area for the display and promotion of alcohol.
- e) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed: display of appropriate signs within the premises detailing the statutory restrictions of the supply of alcohol to minors and the prohibition on sales to intoxicated persons, identification of minors.
- f) According to the Sale and Supply of Alcohol (Fees) Regulations 2013 the premises is assigned the fees category: **Medium – Grocery Store**.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- a) Until the close of the period for which it was last renewed; or
- b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.
