as the user (hereinafter referred to as "User") on the other hand (SHARE NOW and the User hereinafter collectively referred to as "Parties", and each of them as "Party").

1. By entering into this blanket contract (hereinafter referred to as "Blanket Contract"), the User acquires the right to use the services of the community car rental service operated by SHARE NOW (hereinafter referred to as "Service") by creating individual rental contract(s) during the indefinite term hereof subject to the provisions of the SHARE NOW General Terms and Conditions (hereinafter referred to as "GTC").
2. The conditions for using the Service are set out in the GTC and its annexes, in particular, the tariff list. The GTC and its annexes constitute an integral part of the Blanket Contract. The User declares that he has come to know, understood and accepted the GTC (including its annexes) before entering into the Blanket Contract and accepts to be bound thereby.
3. The User declares that, before making his contractual declaration regarding this Blanket Contract, he has received information under Government Decree 45/2014. (II. 26.), including information on the right to withdrawal/cancellation and the termination of an indefinite term contract. The User accepts the Blanket Contract with the same content as in the information and requests SHARE NOW to start providing the Service before the expiry of the time limit for the exercise of such right of withdrawal/cancellation.
4. The User declares to accept and expressly consents to processing his personal data.
5. The Parties shall not be bound by any usage that they have agreed on in prior business dealings and by any practice they have established between themselves, nor by a usage that would be considered generally applicable and widely known in the given sector by parties to similar contracts.
6. This Blanket Contract and the GTC and its annexes include all the conditions for the Services covered by the contract in full. Declarations, offers or commitments made during the contracting that are not included in this Blanket Contract shall not be a part of the contract.
7. As regards claims arising from the Blanket Contract, a notice sent to the other Party, which includes a payment demand and invites for performance, shall interrupt the limitation period.
8. The Parties put on record that they have fully met their obligation to cooperate and provide information in accordance with the relevant legislation prior to and during the conclusion of the contract

SHARE NOW service

Rules of Promotion

Date of issue: 03 March, 2020

The General Terms and Conditions (hereinafter referred to as "GTC") regulate the business relationship between Wallis Autómegosztó Kft. (registered address: 1055 Budapest, Honvéd u. 20., company registration number: 01-09-323961; tax number: 26320731-2-41; hereinafter referred to as "SHARE NOW") and the persons (hereinafter referred to as "Users") who wish to use the community car-sharing system offered by SHARE NOW under Act XLI of 2012 on passenger transport services (hereinafter referred to as "PTA") (hereinafter referred to as "Service"). SHARE NOW provides benefits to its Users, who may be natural persons, legal persons or other entities without legal personality (hereinafter referred together to as "SHARE NOW User") during the performance of the Service according to the present Rules.

1. General statements

- 1.1. Participants in the promotions and benefits: every SHARE NOW User who complies with provisions of the blanket contract under Section 3 of the GTC during the period of the promotion.
- 1.2. SHARE NOW Users automatically accept the provisions of the present Rules through their participation in any promotion that is governed by the present Rules.
- 1.3. The current Rules are available online on the www.share-now.hu Website and in printed form in the central Customer service office.
- 1.4. Promotions can be announced:
 - 1.4.1. on the SHARE NOW Website,
 - 1.4.2. on the SHARE NOW official Facebook site,
 - 1.4.3. in the SHARE NOW Facebook Group ('SHARE NOW-val Csapatom!'),
 - 1.4.4. on the SHARE NOW official Instagram site,
 - 1.4.5. on the SHARE NOW official YouTube channel,
 - 1.4.6. by sending electronic messages (e.g. promotional newsletters or text messages) directly to SHARE NOW Users who have previously consented thereto,
 - 1.4.7. by electronic marketing and promotional messages sent to third parties by other contracted Business Partners of SHARE NOW,
 - 1.4.8. by using other advertising platforms.
- 1.5. SHARE NOW is entitled to suspend, cancel or amend any promotion under the present Rules without prior notice or providing a cause. In this case, SHARE NOW shall inform the SHARE NOW Users in an announcement about the suspension, cancellation or amendment of the promotion, to be posted on its Website.
- 1.6. SHARE NOW credit may be acquired and used only in the SHARE NOW country of registration.

2. SHARE NOW credit

- 2.1. User can receive SHARE NOW credit via registration and refuelling processes, and also via Friend referral programme and SHARE NOW vouchers. SHARE NOW credit is valid only for a certain period of time that is defined when issuing the credit and can be checked and followed in the application. Unused SHARE NOW credit automatically expires and can not be used, renewed, can not be refunded, can not be exchanged to cash or monetary credit and can not be used for paying charges and extra service costs (e.g. extra cleaning fee, administration fee, towing...etc.).

3. Benefits and conditions of promotions

3.1. Free registration

- 3.1.1. Duration: from 18 March 2020 until 1 April 2020 or withdrawn
- 3.1.2. Description and conditions of the benefit: Registration fee for SHARE NOW is € 0, no monetary credit is granted additionally.

3.2. *Benefits of Users holding SuperShop cards*

- 3.2.1. Duration: from 03 March, 2020 until withdrawn
- 3.2.2. Name of the benefit: Point credit for SuperShop Users
 - 3.2.2.1. Description of the benefit: Users holding SuperShop cards can provide their SuperShop plastic card number on the special registration page designed for that purpose. Following successful registration and activation, 500 points will be credited by SuperShop on the SHARE NOW User's SuperShop card. At the conclusion of the first individual rental contract, another 500 points will be credited by SuperShop on the SHARE NOW User's SuperShop card. The SuperShop benefit can only be used by Users who have permanent (plastic) SuperShop cards. The SuperShop benefit does not apply to the holders of provisional (paper) SuperShop cards.
 - 3.2.2.2. Amount of the benefit: Credit entry of 500 points after successful registration and credit entry of another 500 points at the conclusion of the first individual rental contract (rental event).
- 3.2.3. Name of the benefit: Discounted registration fee for SuperShop Users.
 - 3.2.3.1. Description of the benefit: SHARE NOW offers registration into the SHARE NOW system at a discounted price to Users holding a permanent SuperShop card. The discount for joining can only be used for making a new registration. In the case of an existing registration, the 500 points for the first drive cannot be separately credited.
 - 3.2.3.2. The discounted registration fee is 5 990 HUF and 1 490 SHARE NOW credit will be credited on the User's balance.

3.3. *SHARE NOW credit for incentivising refuelling*

- 3.3.1. Duration: from 03 March, 2020 until withdrawn
- 3.3.2. Description and conditions of the benefit: If a SHARE NOW User refuels the rented car according to the provisions of the GTC by using the fuel card of the car, User receives 1 990 SHARE NOW credit for refuelling. SHARE NOW credit is granted for refuelling if the fuel level drops to or below 25% but not below 10%. Simultaneously, the conditions that the fuel level of the car must be 90% or above when the car is locked must also be fulfilled at the same time. The SHARE NOW credit is used upon the conclusion of the individual contracts (rental events) made after the credit entry and SHARE NOW will automatically credit any unused bonus minutes or SHARE NOW credit into the fee payable for the current rental event. SHARE NOW credit that has not been used during such 30 day period cannot be renewed and will be cancelled from the SHARE NOW User's account after the expiry of 30 days.
- 3.3.3. Amount of the benefit: 1 990 SHARE NOW credit

3.4. *Benefit of the Drive'n Save and Happy Hour promotions*

- 3.4.1. Duration: from 03 March, 2020 until withdrawn
- 3.4.2. Description and conditions of the benefit: SHARE NOW can define certain occasions when some or all models in the fleet can be rented at a lower minute price when choosing minute-based rental construction.
- 3.4.3. Discount lasting for certain hours (Happy hour) can be used only in the given period of time. Discount is validated automatically when starting the rental. If a rental ends after the discount period, the rental time between the end of the discount period and the end of the rental will be invoiced according to the default minute price of the car model used.
- 3.4.4. Drive'n Save discount is always marked in the application with a % sign. Discount is validated automatically when starting the rental. After ending the rental with a Drive'n Save discounted car, the given car can be re-rented at the default minute price of the model. Discount can not be revalidated after ending the rental.

Exemption of the Insurance Company

Date of issue: 02 March, 2020

The General Terms and Conditions (hereinafter referred to as "GTC") regulate the business relationship between Wallis Autómegosztó Kft. (registered address: 1055 Budapest, Honvéd u. 20., company registration number: 01-09-323961; tax number: 26320731-2-41; hereinafter referred to as "SHARE NOW") and the persons (hereinafter referred to as "Users") who wish to use the community car-sharing system offered by SHARE NOW under Act XLI of 2012 on passenger transport services (hereinafter referred to as "PTA") (hereinafter referred to as "Service"). SHARE NOW provides benefits to its Users, who may be natural persons, legal persons or other entities without legal personality (hereinafter referred together to as "SHARE NOW User") during the performance of the Service according to the present Rules.

SHARE NOW is entitled, but not obliged, to conclude an all-risk (Casco) vehicle motor insurance for the vehicles with own risk of its choice.

SHARE NOW draws attention to the following cases, when the Insurance Company's risk liability is exempted. In these cases User's liability is unlimited and extended to the limit of the total amount of the damage caused and to other related costs that may occur.

Exemption of the Insurance Company

The insurance company shall be partially or completely exempted from its payment obligation if it proves that the event resulting in the vehicle breakdown was caused by any of the insured, the policyholder, members or organizations involved in the operation of the vehicle by acts of illegal or deliberate conduct or gross negligence.

These cases include

- any of the individuals above drove the vehicle in a state of intoxication with a their blood alcohol level under 0.8‰ and/or with their breath alcohol level under 0.5 mg/l, or under the influence of drugs, or in a state unfit for driving or allowed a person in any of such states to drive the vehicle;
- inefficient vehicle operation;
- breaching official regulations of the vehicle;
- damage was caused by the overload of the vehicle;
- damage was caused by improper fixing of cargo.

The insurance company shall not indemnify for loss and damage if, upon the occurrence of the insured event, the authorized driver of the vehicle in traffic did not have a valid driving license unless it is proven by the policyholder/insured that this fact did not contribute to the occurrence of such insured event. A legitimate driver shall mean a person who drives the vehicle in conformity with the will of the policyholder or the person authorized to dispose over the vehicle.

The insurance company shall not indemnify for loss and damage if the blood alcohol level/breath alcohol level or state of stupefaction under the influence of drugs or the state unfit for driving of the driver of the vehicle as at the time of loss cannot be determined because the driver of the vehicle withdraws from measures by the police or declares to have consumed alcohol or any substance otherwise detrimental to the capacity to drive between the insured event and the alcohol test or any other medical/expert examination and as a consequence of the above blood alcohol level/ breath alcohol level data or other substantial circumstances in respect of the capacity to drive have become impossible to ascertain.
