What is SafePet?

SafePet was established in 2003 by the Ontario Veterinary Medical Association to assist women leaving

abusive partners by providing temporary housing for their pets. The program matches volunteer pet foster parents — who register through veterinary clinics in Ontario — with the pets of abused women (and their children) who are seeking safety in women's shelters but don't have anywhere to leave their pets.

Why is SafePet an important program?

Every day women across Ontario leave abusive partners. The decision to leave home often saves their lives and the lives of their children. Deciding to leave and then actually doing so, is not easy. For many women, the decision to leave is often further complicated by a reluctance to leave their pets behind in absence of temporary housing options.

48% of surveyed Ontario women who had left their abusive partner said that their pets delayed their decision to leave an abusive partner.*

61% of surveyed Ontario women who had left their abusive partner stated that their partners had brutalized or killed a pet.*

That's where SafePet and caring people like you can make a world of difference.

How can you help?

By opening your home and becoming a pet foster parent through SafePet you can offer peace of mind to an abused woman for whom the temporary placement of her precious pet provides the support needed to seek safety.

How does SafePet Work?



Step One Register as a 'pet foster parent'

Individuals interested in becoming pet foster parents through the SafePet program must register for the program through a local veterinary clinic.

Individuals applying to become pet foster parents through the SafePet program will be asked to identify the following:

- The type(s) of animal(s) you are willing to house.
- The length of time you are willing to look after a pet.
- Any restrictions you might have (e.g., size/weight of pet).

Step Two Pets are matched with pet foster parents

Women's shelters seeking temporary pet foster parents on behalf of women entering a shelter can arrange this through a local veterinary practice. This process is confidential. As a safety measure for both the abused women and volunteers, the woman's identity is never disclosed.

All volunteers need to be confident that they can provide a safe temporary home for pets.

Step Three Fostering a pet until its owner is able to care for the pet

When a pet matching a pet foster parent's pre-determined specifications is identified, veterinary staff will call the pet foster parent into the clinic to meet the pet(s), review care instructions and discuss other issues for the temporary placement of that pet (e.g., diet, medical needs, exercise). The pet then goes to the pet foster parent's home. The pet foster parent must agree to provide the pet with its appropriate diet, excercise and other special needs as required.

During the pet's shelter period, the pet foster parent may consult with the participating veterinarian if any concerns or health issues arise.

Step Four Pet is returned to a healthy family environment

The animal(s) is returned to the veterinary clinic when the abused woman (a) has found longer-term arrangements for her pet(s), (b) is once again able to take care of her pet(s), or (c) when the pre-determined timeframe has ended.

A volunteer is under no obligation to continue to house a pet if an arrangement does not work. Both the volunteer and the woman seeking assistance with her pet(s) sign legal documents to eliminate confusion with regard to expectations.

Who should become a temporary pet foster parent under the SafePet program?

If you love animals and if you care about the people in your community, please consider offering shelter to a pet through the SafePet program. If you are not sure that you are a suitable pet foster parent, feel free to discuss your eligibility with a local veterinarian.
