

BOARDING POLICY

WE WELCOME YOU AND YOUR PET TO WHITE PINE. OUR STAFF WILL PROVIDE ALL THE FARE FOR YOUR PET, INCLUDING A BALANCED DIET, EXERCISE AND INDIVIDUAL CARE TO MAKE THE BOARDING STAY A COMFORTABLE EXPERIENCE. PLEASE READ OVER THE FOLLOWING REQUIREMENTS.

1. **HOURS:** Monday Thru Friday 8:00 AM - 5:30 PM; Saturday 8:00 AM - 3:00 PM. Pets will not be admitted or released out of hours, Sundays or holidays.
2. **CHARGES:** A boarding charge is made for each day of your pet's stay at White Pine. This means you will be charged for the day your pet is admitted and discharged. A deposit may be required. All charges are to be paid in full at the time of discharge.
3. **REQUIRED VACCINES:** White Pine requires current immunizations of the following: Distemper-Hepatitis-Parainfluenza-Parvo virus-Bordetella-Rabies for dogs.
Feline Panleukopenia-Rhinopneumonitis-Calici virus-Rabies for cats.
If your pet has received its immunization at our hospital we will consider your records as proof of vaccination; otherwise, we ask you please bring certificates of vaccination to be kept on file during your pet's stay with us. There will be no exception to this rule. This is important for the health of your pet and those of others staying with us.
4. **FOOD:** While left in our care your pet will be fed IAMS diet in accordance with its age and weight. Special diets such as Prescription Diets are available upon request at an additional charge of \$1.00/day.
5. **PERSONAL ITEMS:** We will have you keep your pet's leashes and collars with you as you admit your pet. Also, toys, blankets, cat carriers, etc. are discouraged to be left as we provide all of these. If personal items are left we will do all we can to return them, clean and in good shape, but cannot be responsible for lost or damaged items.
6. **MEDICATIONS:** Pets on medications or special diets will continue to receive them while staying with us. Prescription diets and medications will not be given without Veterinary authorization. There will be a charge of \$1.00/day for medicating any pet when the owner provides the medication. We offer individualized attention and care to each pet staying with us. We pride ourselves in this. At White Pine our trained staff is always alert to any unusual signs. Should any appear, your pet will be examined immediately by the doctor on duty. You may also authorize medical treatment for your pet during its stay. If your pet has had surgery or medical treatment during its stay at White Pine and you wish to discuss your pet's condition, continued treatment and home care with the doctor please allow time for this at time of discharge.

If my pet would become ill or injured during my absence I understand the White Pine Veterinary Clinic will treat my pet as a regular medical or surgical patient. This is to include all necessary examinations and the performance of any diagnostic procedures and/or tests that are essential to establish a diagnosis and to administer any drugs, medications, fluids or perform any emergency procedures to sustain my pet's life. The owner will be responsible for any expense incurred.
