## 2026 STALLION SERVICE AGREEMENT

I, \_\_\_\_\_, (the 'Mare Owner'), hereby agree on \_\_\_\_\_ (the 'Effective Date') to enter into this Agreement with B & A Performance Horses ('Breeder') to breed the following mare, \_\_\_\_\_ (the 'Mare') Registration # \_\_\_\_\_, to the stallion HESA BLUHADI (AQHA 6144323) (the 'Stallion') for the 2026 breeding season(March 1st- May 31st)subject to the following terms and conditions.

1. BREEDING FEE. The breeding fee to the stallion is \$1200 starting January 1st, 2026 and includes only the following:
  - a. Stallion fee
  - b. Applies only to calendar year/breeding season booked pursuant to this agreement.
  - c. Due with signed contract and must be paid in full prior to the mare being bred on-site OR any cooled semen being shipped or picked up.
  - d. Photocopies of registration papers shall be sent with contract. The owner recorded on the registration certificate will be the owner recorded on the stallion breeding report.
2. SHIPPING/PICK UP FEES. All shipping and pick up fees will be the sole responsibility of the mare owner, and must be paid in advance or charged to the credit card on file, and are as follows:
  - a. \$265.00 Collection Fee for On-Farm Mares and Cooled Semen Pick Up
  - b. \$345.00 Cooled Semen Collection/Shipment – Priority Overnight (Includes collection and FedEx fees.)
  - c. \$530.00 Cooled Semen Collection/Shipment – Counter to counter. (Same day delivery includes collection, courier, and airline fee.)
  - d. There may be times when stallion is not available to be collected due to show schedule.
  - e. Once the shipment of stallion's semen leaves breeding facility, all loss, damages, delays, etc. are the responsibility of the mare owner. There will be no refunds for lost, delayed, or damaged shipments.
  - f. Orders for semen must be made 24 hours in advance. **Call Abraham's Equine Clinic at 319-366-6441 to order semen.**
  - g. In the extreme event that shipping rates increase far beyond forecasted expectations AEC will re-evaluate shipping cost.
3. PRIORITY- Mares at the breeding facility have breeding priority on any given day, therefore the breeder makes no guarantee cooled semen will be available for any specific day. In the event of insufficient semen on a particular breeding day, breeder will ship on a first ordered, first served basis. If cooled is unavailable, breeder will make every effort to offer frozen semen.
4. DOSES- Mare owners requesting shipped semen should expect to receive only 1 dose of semen. Two doses will be sent if available.
5. BREEDER RESPONSIBILITY- Breeder assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during or after shipment, loss of viability, or any other losses incurred from shipments lost, delayed, or damaged.

6. BREEDING SEASON- This Agreement is valid for the 2026 breeding season only. The Mare Owner may NOT enter into this Agreement with the intent to use in a subsequent season. In the event of this Agreement being paid in full, and the Mare never being bred, this shall become a rebreed for the following season ONLY. An additional Collection/Shipping Fee will be due at that time, and any difference in Stallion Fee is payable to the Stallion Owner.
7. MARE OWNER RESPONSIBILITY- The Mare Owner hereby represents and warrants it is the owner of record of the Mare. The mare shall be in sound breeding condition, free from infections and/or contagious diseases, and current on all vaccinations and deworming, prior to breeding. A current negative Coggins test and health and immunization records shall accompany the mare if managed at AEC. AEC reserves the right to refuse any mare presented in unsatisfactory condition.
8. STANDARD OF CARE- Abraham's Equine Reproduction Center will meet or exceed the standard of care for all mares/foals on premises. AERC will examine on-site mares for reproductive and overall health and will administer medical care and farrier service as deemed necessary. The mare owner agrees to pay for needed medical treatments/farrier services necessary to provide the standard of care by AERC. AERC/stallion owner shall not be liable in any way for the mare failing to conceive, loss of pregnancy, injury, illness, or death of the mare or foal in their care for the purpose of fulfilling this contract. Insurance is the responsibility of the mare owner, and AERC can assist with insurance exams for coverage on a mare, foal, or foal in utero.
9. CONTAINERS- Mare owner is responsible for returning the shipping container to AEC within 5 days of receiving it. The container may be shipped via FedEx or UPS Ground Service. Your credit card will be charged if not returned within that time frame.
10. BREEDING REPORT- It is the mare owner's responsibility to report the pregnancy status of said mare to be included in the stallion breeding report. This contract provides for one (1) breeder certificate. If multiple embryos are retrieved from one breeding, an additional breeding fee will be assessed. It will be the responsibility of the mare owner to notify AERC of the number of embryos transferred. If multiple embryos are desired and it takes more than one breeding, an additional contract will be required for each breeding. It is mare owner's responsibility to notify AEC when embryos are frozen and utilized.
11. LIVE FOAL GUARANTEE/REBREEDS- If the Mare does not produce a live foal the first breeding season, the Mare Owner is entitled to a rebreed the following year only. The Mare Owner will be subject to an additional collection/shipping fee, plus any additional attending veterinarian fees. The mare owner understands that they are responsible for all costs and expenses associated with insemination of the mare.
  - a. Live foal means the foal shall stand and nurse without assistance. It is understood that if the mare proves barren, aborts her foal, or if foal is born stillborn, a return breeding will be guaranteed the following year only at The Ranch Equine, Inc., providing that proper notification is received within 7 days of the occurrence. A live foal guarantee will apply to those mares that are certified in foal by a licensed veterinarian. Confirmation must be sent to The Ranch Equine, Inc. in order to guarantee a rebreed. Confirmation can be in form of letter from attending licensed veterinarian. Breeder does not make any warranty or representation as to the quality or conformation of the foal, merchantability or fitness for a particular purpose, or that the foal will be free of any infirmity, conformation defect, disease or inherited trait.
  - b. If the Mare Owner fails to return the mare for breeding the following year, then all fees paid shall be forfeited, the right to rebreed is terminated and the Stallion Owner is released from all further obligation of the contract, unless otherwise agreed to in writing and signed by all parties.
  - c. All rebreeds and donated breedings are subject to the collection/shipping fee. Any breedings that are won through Social Media Promotions that are performed by Breeder will include a live foal guarantee. They are valid only for the year the breeding was won.
12. PREGNANCY STATUS- It is the Mare Owner's responsibility to notify Breeder of the pregnancy status within thirty-five (35) days of insemination. Failure to contact Breeder By August 1st will result in a \$100.00 late fee to add the Mare to the Stallion Breeding Report.
13. MARE SUBSTITUTIONS-If the Mare dies or becomes unfit to breed after execution of this Agreement the Mare Owner may transfer the breeding to a substitute mare owned by Mare Owner. Upon notification to Breeder of any substitution, Mare Owner agrees to enter into a separate Agreement as to the substitute mare. Mare Owner will be responsible for additional collection/shipping fees. No additional breeding fee will be charged.

14. STALLION- Should the Stallion die or become unfit for service for any reason, then this Agreement shall become null and void and both parties are relieved of any further obligation hereunder. Stallion Owner will attempt to fulfill Agreements via frozen semen at their sole discretion. Any amounts paid by the Mare Owner toward the Stallion Fee, shall be refunded at the sole discretion of the Stallion Owner. Additionally, Breeder makes no representations or warranties as to the potential of Stallion to achieve or maintain success as a producer of quality offspring.
15. BREEDER'S CERTIFICATE- To obtain a Breeders Certificate, the Mare Owner must notify Breeder of the birth of the foal. The Breeders Certificate will not be issued or released until the account has been paid in full and all terms hereunder adhered to.
16. EMBRYO TRANSFERS- The Mare Owner agrees to notify Breeder if this is an embryo transfer mare. In the event of multiple embryos from a single flush, Mare Owner agrees to notify Breeder once the additional recipient mares have been confirmed in foal with a heartbeat present. The Mare Owner must then pay a Stallion Fee equal to the aforementioned Stallion Fee for each additional Live Foal. The additional Stallion Fee is due upon the additional foal(s) standing and nursing. Additional Breeder Certificates will be issued upon receipt of necessary stallion fee(s).
17. SOCIAL MEDIA- The Mare Owner agrees that nothing shall be posted or shared via social media that could be negatively construed regarding Breeder, or any of its members, managers, employees, associates, or affiliates. Failure to do so may result in legal action regarding the content and damages associated with such action. Furthermore, Breeder reserves the right to terminate this Agreement in the event this Agreement is breached. Any offending Mare Owner shall immediately forfeit any fees, payments or right to a rebreed.
18. OTHER- The mare owner will sign and return the contract with the breeding fee to the stallion owner, and it will become a binding contract on both parties at that time, subject to above terms and conditions. In the event of a dispute between parties arising out of this contract, is submitted to a court of competent jurisdiction to arbitration, mediation or to any combination thereof for resolution. The prevailing party shall be entitled to all costs of such proceedings, including attorney fees. This contract shall be construed according to the laws of Mitchell County in the State of Iowa, to the exclusion of laws of any other jurisdiction.
