Without proof of current vaccinations, Countryside Pet Clinic will perform an exam and administer the required vaccines and the appropriate fees will be charged. All animals admitted must also be free of external parasites. **Any animals found to have fleas, mites, or ticks will be treated at the owner's expense.**
