



**OPEN DOCK RULES AND RELEASE**

**I understand, accept, and attest to the following:**

- Any medical conditions or physical ailments that my dog may have can be aggravated by dog sports courses and accept any consequences of my decision to participate.
- Any medical conditions or physical ailments that I may have can be aggravated by dog sports courses and accept any consequences of my decision to participate.
- My dogs is current on Rabies, DHLPP, and Bordetella and has had a negative fecal exam within the last six months. Failure to provide proof of these vaccines can result in immediate removal from services.
- There no complaints or citations pertaining to my dogs.
- I understand if my dog is too reactive, aggressive, or disruptive, I will be asked to leave class without a refund.

**RULES:**

- There is a \$75 charge if your dog defecates or urinates in the pool to cover the cleaning the pool.
- Please do not let your dog relieve themselves anywhere in the pool area. Take your dog to the potty area located on the side of the building's front entrance. Any dog that has more than 2 accidents in the pool/training areas will not be allowed back. Please pick up after your dog, failure to do so can result in you being asked to leave. If you take your dog(s) out prior to pool/training time, this should not be an issue.
- You are responsible for the safety of your dog and any people you bring with you to Open Dock.
- Finally, No Leash Needed believes dog sports are meant to be fun and engaging with your dog. If you are disruptive to other participants or your dog is too reactive or aggressive with other dogs, we reserve the right to refuse services. You will not be refunded if you or your dog is asked to leave.
- Please do not bring additional any dogs to the facility. Any dog in the pool area will be charged the entrance fee.

## ***Dog Sports Classes Release***

Dog Sports require physical activity on your dog's part and on your part. No Leash Needed (NLN) assumes that you understand this and have made an informed decision on whether participation in this class is appropriate for you and your dog. Please also be advised, that while we do allow minors in class with you, they are bound by this agreement as well.

### **AGREEMENT TO RELEASE AND WAIVE LIABILITY, HOLD HARMLESS, INDEMNIFY AND ASSUME RISK OF INJURY OR LOSS**

The undersigned hereby agrees as follows:

1. The undersigned is an individual or the parent or other responsible party for an individual. The undersigned hereby binds, to the greatest extent possible under applicable law, themselves, and/or their minor child, by their signature hereto.
2. The undersigned for himself, or on behalf of any minor child, assumes all the foregoing risks and accepts personal responsibility for damages which may hereinafter occur following such injury, permanent disability or death.
3. The undersigned acknowledges and fully understands that they will be engaging in activities that involve risk of serious injury, including permanent disability and death and severe social and economic losses which might result from their own actions, inaction or negligence of others, the rules of play, or the condition of the facility or of any equipment used. Further, the undersigned acknowledges and fully understands that there may be other risks not known to NLN or reasonably foreseeable at this time.
4. NLN is not responsible for lost, stolen or damaged items.
5. The undersigned shall be liable for any and all damage to the facility, clean up (ex Defecation in pool) or other expenses, including reasonable attorneys' fees in collecting such sums.

I understand that my attendance in a dog class is not without risk to myself, my dog, other family members or guests, and other class participants (human or canine). These include, without limitation, risks of physical injury, mental injury, emotional distress, trauma, and death, contact with other participants and their dogs and property damage. All risks are known and appreciated by me. I waive any and all specific notice of the existence of the risks. I shall assume and pay my medical and emergency expenses in the event of injury, illness, or other incapacity regardless of whether I authorized such expenses. I agree that I, as owner of the above dog, am solely responsible for the animal's behavior and physical control and agree to carefully monitor and control my dog at all times.

By reading, signing, and dating this document, I hereby waive and release No Leash Needed\*, its owners, and/or owners of all premises on which these classes are being held, and/or its employees, agents and volunteers of said owners, from any and all damages, losses, fines, claims, suits, expenses (including attorney fees and defense costs ), judgments, and/or liabilities of any form or nature resulting from any act or omission of any dog or dog owner participating at No Leash Needed. This release of liability includes, but is not limited to, any injury, death, sickness, or personal injury or property damage my pet or I may suffer while on or around the premises where the training is held. This release also includes specifically, but without limitation any and all forms of personal injury (including death) and property damage to myself, other persons, and other animals resulting from the act or omissions of any and all dogs or dog owners, and I expressly assume the risk of such damages or injuries and losses throughout the duration of the training curriculum.

I also agree to defend, indemnify and hold harmless No Leash Needed, its owners, and/or the owners of all premises on which these classes are being held, and/or the employees agents , and volunteers of said owners from any and all claims , suits, losses, damages, expenses (including attorney fees and defense costs) judgments, fines, penalties and/or liabilities, due to any and forms of personal injury (including death), property which my pet or I may cause, or be alleged to have caused, to any person, animal, or property while or around on the premises where the training sessions are carried out, or in connection with the training services provided by No Leash Needed. This Agreement to Release and Waive Liability, Hold Harmless, Indemnify and Assume Risk of Injury or Loss shall survive the completion or termination of dog training services through No Leash Needed. This agreement is an integrated agreement which supersedes any prior, contemporaneous oral or written agreements or negotiations. This agreement may not be modified except through a written agreement signed by both the dog owner and a managing member of No Leash Needed.
