payable upon execution of this contract. The following conditions of service are mutually agreed between Mare Owner

- 1. Stallion fee is due with the signed contract. Mare Owner agrees to provide a photocopy of the mare's registration papers with the breeding contract.
- 2. Once completed breeding contract and registration papers have been received with payment, the contract will either be approved or denied. If approved, the contract will be signed, and a copy returned to the mare owner.
- 3. Semen is collected, stored, frozen, and distributed by Abraham's Equine Clinic, Location #1276, located at 625 Dows Road SE, Cedar Rapids, Iowa 52403. Payment by credit card to Abraham's Equine Clinic is required prior to shipment for all shipping costs. All shipment requests must be made at least 24 hours in advance. Shipment requests can be made Monday thru Friday 8am-5pm. Semen orders must be placed the day before by calling 319-366-6441. \$84 frozen semen insemination fee for on-farm mares (other fees will apply; including but not limited to mare care, medications, etc.). Frozen Semen Shipment (Overnight only) \$260 container fee plus actual shipping cost. Shipments may only be sent on a Friday if Saturday delivery is available in your area. Please see repro services list for a complete listing of services and prices for AEC or contact them directly with questions.
- 4. All shipping expenses (FedEx shipping fee to and from Cedar Rapids, Iowa to requested address) and container fee (\$260/shipment) are the responsibility of the mare owner and should be paid directly to Abraham's Equine Clinic (625 Dows Road SE, Cedar Rapids, Iowa 52403 319.366.6441). If Abraham's Equine Clinic provides the shipping container, the container is the property of Abraham's Equine Clinic. Should the mare owner fail to return the shipping container within 2 business days after receipt, a \$260/day rental fee will be charged. After 7 days \$1200 will be charged to Mare Owner to cover the cost of the container or if there is any damage to the container. Any loss or damage to the container will be the responsibility of the mare owner. Containers will be shipped with a prepaid FedEx return label. The cost of returning the shipping container is the responsibility of the mare owner and will be charged prior to the shipment. Abraham's Equine Clinic has limited number of dry shippers, it is best to request the frozen semen well ahead of time to avoid delay since orders are shipped on a first serve basis.
- 5. Mare owner or veterinarian must have a storage tank to transfer frozen semen upon arrival so that the shipper can be returned immediately.
- 6. Insemination must be done by a licensed veterinarian at a reputable clinic.



- 7. Mare should be healthy and in sound breeding condition. A veterinarian letter stating proof of negative uterine culture will be required prior to shipment. This must be emailed to abrahamsequine@aol.com ATTN: Emilie.
- 8. Stallion fee includes one dose of frozen semen. If mare owner would like an additional dose of frozen sent at the same time, a fee of \$150 to stallion owner will be required to be paid prior to shipping. Shipping, and all other reproduction services are the responsibility of the mare owner. (Please contact Abraham's Equine Clinic for fee information).
- 9. Additional doses purchased, but not used for an already paid stallion contract can be used if a new contract is completed and approved by Hockenson Quarter Horses prior to use.
- 10. If the mare does not conceive after two cycles, a cytology, or biopsy is required before any further semen is shipped to avoid inadvertently wasting frozen semen.
- 11. Mare owner agrees to have the mare checked by ultrasound and to provide Hockenson Quarter Horses with the results of the pregnancy exam no later than 30 days after the examination of the mare.
- 12. If the mare aborts or fails to conceive, she may be re-bred the following year only, provided all fees have been paid with the original contract. A re-breed fee of \$150 per dose (max of two doses can be shipped) will be required by the mare owner as well as any applicable container and shipping fees. Vet letter of proof of negative culture will be required prior to shipment. Pnuemabort vaccines must be given at 5, 7, and 9 months of pregnancy. Proof of Pnuemabort vaccines will be required in the case of a rebreed due to abortion.
- 13. Live foal guarantee: If foal is unable to stand and nurse within 24 hours of birth, born dead or is recommended to be euthanized by vet due to life threatening birth defects, a rebreed contract will be provided to the mare owner. A letter from vet will be required. Re-breed must be used the following year and will no longer be valid if not used.
- 14. The mare owner agrees to use all semen provided by the Agreement for the mare in this contract and no other. A substitute mare may be used only if the original mare is deceased or is deemed unfit for breeding by an accredited veterinarian and must be approved by Hockenson Quarter Horses.
- 15. Mare owner agrees to notify Hockenson Quarter Horses if this is an embryo transfer mare. In the event of multiple embryos from a single flush, mare owner agrees to pay a Stallion Fee of \$1500 for each additional live foal. Additional breeder's certificates will be issued upon receipt of all applicable fees being paid.
- 16. A breeder's certificate will be issued upon notification of the birth of the foal, only after confirmation that all fees are paid in full including any board bills, shipping charges, container fees, or veterinary charges that were owed by the mare owner.
- 17. Abraham's Equine Clinic only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. Abraham's Equine Clinic does not guarantee the fertility of any stallion but agrees to ship only commercial quality frozen semen with a documented post thaw motility of 30% or greater. CD Dyna Cee's frozen semen quality is good and has resulted in pregnancies.



- 18. Should the frozen semen become damaged or depleted prior to shipment, then this contract shall become null and void and both parties are relieved from any further obligation hereunder, and any monies paid by the mare owners shall be refunded.
- 19. There will be no exceptions to the terms of this contract, and it is not transferable unless provided in writing and signed by all parties.
- 20. The parties hereto specifically agree that this Agreement shall be construed, governed, and interpreted by and in accordance with the internal laws of the State of Iowa, and the proper place of venue shall be Muscatine County, Iowa. Under Iowa Law, Section 673, A person, including a domesticated animal professional, domesticated animal activity sponsor, the owner of the domesticated animal, or a person exhibiting the domesticated animal, is not liable for the damages, injury, or death suffered by a participant or spectator resulting from the inherent risks of a domesticated animal activity.
