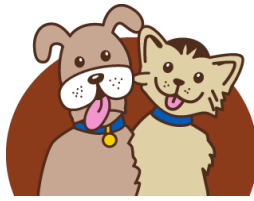

## **Animal Medical & Surgical Hospital of Frisco: Boarding & Medical Release**

### VACCINATION REQUIREMENTS:

To ensure a safe environment for your pet as well as the other animals in our care, Animal Medical & Surgical Hospital of Frisco requires all animals staying in our facility to maintain current vaccination status. Annual vaccinations must be current within a twelve-(12) month period. Bordetella requires a six-(6) month booster. If your pet does not receive veterinary care at this hospital, written proof of current vaccinations or the name of your attending veterinarian for telephone verification is required.

### MEDICAL EMERGENCY:

Should a medical emergency occur during your pet's stay at Animal Medical & Surgical Hospital of Frisco will be stabilized at your own expense. Treatment beyond stabilization will require your consent. In the event of a life-threatening condition, and you are unable to provide immediate consent, do you authorize the veterinarians at Animal Medical & Surgical Hospital of Frisco to provide medical treatment for that condition?

### GUEST BELONGINGS:

We welcome toys for your pet's entertainment, but we do not assume liability for the loss or destruction of any item accompanying . Please let us know if your pet has a history of stress anxiety (will destroy / eat bedding) so that we can take the necessary precautions.

### DEPARTURE:

Overnight lodging is charged on a per-night basis. Animals who arrive with fleas will be bathed and the charge will be added to your invoice.

### PAYMENT:

I agree to pay all charges on the day of pick-up of my pet, and I understand that my pet may not leave the premises until all charges are paid in full. According to Texas State Law, I understand that unless other arrangements have been made, any animal left for twelve-(12) days beyond the agreed pick-up date, will become the possession of Animal Medical & Surgical Hospital of Frisco.
