- ALL PETS PRESENTED FOR SURGERY MUST BE CURRENT ON **RABIES** AND **DISTEMPER** VACCINATIONS. A COPY OF A CURRENT RABIES CERTIFICATE OR CONFIRMATION BY TELEPHONE FROM THE VETERINARIAN ADMINISTERING THE VACCINATION IS REQUIRED. **A RABIES TAG IS NOT ACCEPTABLE.**
- DOGS MUST HAVE BEEN VACCINATED FOR **KENNEL COUGH** WITHIN 6 MONTHS OF ADMISSION. DOGS MUST ALSO BE VACCINATED FOR THE **K9 INFLUENZA VIRUS**. THIS VACCINE REQUIRES A BOOSTER WITHIN 3-4 WEEK AFTER THE INITIAL VACCINE.
- ANY ANIMAL FOUND TO BE HARBORING EXTERNAL OR INTERNAL PARASITES WILL BE TREATED AT THE OWNER'S EXPENSE.

### **THE FOLLOWING TREATMENT OPTIONS ARE AVAILABLE AT AN ADDITIONAL COST:**

**POST OPERATIVE PAIN MANAGEMENT.** The following options are available for controlling post-operative pain:

- Single dose injection of post-operative pain medication **REQUIRED:** \_\_\_\_\_
- Oral pain medication dispensed (dogs only) and cats as deemed necessary **ACCEPT:** \_\_\_\_\_
