

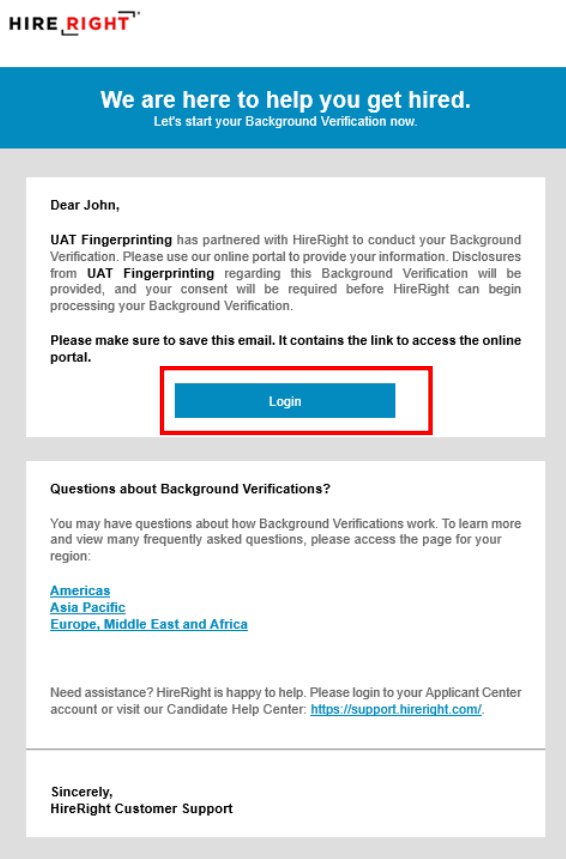
FBI Fingerprinting Candidate User Guide



The following user guide covers the candidate experience for FBI Fingerprinting in Applicant Center and the Fingerprinting Portal.

Step 1: Completing Your Applicant Center Form

As a part of your background check, you will have received an email from noreply@hireright.com inviting you to submit your required information in our Applicant Center. Below is an example of the email:



Please click on the "Login" button to access our Applicant Center. After clicking on "Login," you will be taken to Applicant Center where you will be asked to create a new password. Follow the password creation instructions to create your new password if this is your first time logging in

Once you are logged in to Applicant Center, you will be asked to submit the information required to complete your background checks. This includes submitting personal information as well as information specific to your required

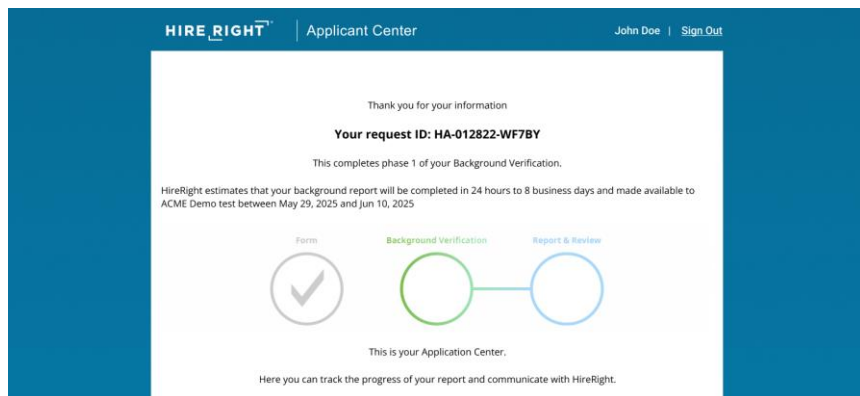

After completing all the required forms and consents you will be presented with a thank you page that contains your Request ID. This page also contains the information required to complete your fingerprint capture.

Step 2: Scheduling Your Fingerprinting Appointment

If your employer has elected for a Live Scan fingerprint capture, you will see a section on this page titled "Schedule Your Fingerprinting Appointment." Click on the "Schedule My Fingerprinting Appointment" button to be taken to the fingerprinting portal where you will enter the information required for fingerprint capture, as well as schedule your fingerprinting appointment.

Step 3: Requesting a Hard Card Fingerprint Capture

If you did not find any locations within a convenient distance in the fingerprinting scheduler, you can return to Applicant Center via the email you received and check the box that says, "I confirm that there are no live scan locations near me, and I am requesting a Hard Card fingerprint capture."

Follow the instructions in the PDF to complete your Hard Card fingerprint capture. After completing the Hard Card fingerprint capture, please **mail** your hard card to the address listed in the Hard Card instructions. When HireRight receives your completed Hard Card, the fingerprints will automatically be channeled to the FBI for processing, and your employer will receive a copy of your FBI results.

Step 4: Fingerprint Rejection & Resubmission

If your initial fingerprint submission does not meet the FBI quality standards, they will reject your submission and request a new set of fingerprints. If this is the case, you will receive an email notifying you that your fingerprints have been rejected due to quality issues and you are required to submit a second fingerprint capture.

This email will contain a QR code as well as information regarding acceptable forms of identification which you will need to bring to your second capture appointment. Please go to the original capture location and complete a second fingerprint capture.
