ITEM 529.1	Service Description	
	An Integrated NewsRoute service provides for occasional-use inter-exchange transmission of data files or broadcast quality video and audio through an Electronic News Gathering (ENG) box to the closest in-province Television Operations Centre (TOC). The video interface shall include autosensing capability to analogue, digital or high definition HD video.	
ITEM 529.2	Conditions of Service	
	<ol style="list-style-type: none">1. The service is provisioned over unprotected inter-exchange facilities between any Company occasional-use serving locations and the associated Company TOC.2. The service is provided subject to the availability of suitable Company equipment, facilities or technology.3. The local loop access to be used with the Integrated NewsRoute service will be provisioned at additional charges as follows:<ol style="list-style-type: none">a. Local Broadcast Transmission Local Loop Service (TCC General Tariff CRTC 21461 item 528)4. Cancellation charges are applicable in the following circumstances:<ol style="list-style-type: none">a. A cancellation charge of 100% of the scheduled charges applies if the Customer cancels after the beginning of the scheduled transmission time, or less than 24 hours prior to the beginning of the scheduled transmission time, as booked by the Customer.b. A cancellation charge of 50% of the scheduled charges applies if the Customer cancels less than 72 hours <u>and</u> at least 24 hours prior to the beginning of the scheduled transmission time as booked by the Customer.c. No cancellation charges apply if the occasional service is cancelled at least 72 hours prior to the scheduled transmission time as booked by the Customer.

Conditions of Service - Continued

- d. Any change or rescheduling of a reservation within 72 hours of the beginning of the scheduled transmission time as booked by the Customer will result in cancellation charges identified in Items 529.2.4.a and 529.2.4.b, except under the following conditions:
 - i. the Customer changes the beginning of the transmission time to an earlier start time;
 - ii. the Customer changes the end of the transmission time to a later end time; or
 - iii. the Customer reschedules the service to a later time. The rescheduled service must be the same service end points as the originally scheduled service. A reservation may be rescheduled only once. Reservations which are rescheduled and then cancelled are charged a cancellation charge of 100%.

Rates

The Customer shall pay to the Company the following rates and charges for an Integrated NewsRoute service. Such rates and charges are in addition to any other rates and charges that may be applicable.

Service Item	Minimum Usage Charge	Maximum Usage Charge
First 15 minutes (or fraction thereof) – per connection	#	\$250.00
Each additional 15 minutes (or fraction thereof) – per connection	#	\$100.00
Switching Charges for point-to-multi-point network configuration – per switch or point	#	\$150.00
Switching Charges for point-to-multi-point network configuration – per contracted switch or point (Note 1)	#	\$500.00
