ITEM

526.1 **Service Description**

Provides on-site carrier system for the transmission of a minimum of 24 voice/data channels.

ITEM

526.2 **Conditions of Service**

1. Minimum Maintenance Period: 10 years. (Note 1)
2. Total charges for Multi-Plan Services are the sum of a fixed Tier 'A' Rate which relates solely to the equipment on the customer's premises and applies for a specified payment period, and a Tier 'B' rate which relates to continuing operating costs and applies for the life of the service.
3. All Multi-Plan Services (including the ordering of equipment) shall be provided by the Company and received by the customer in accordance with the terms and conditions as set forth in the form of Multi-Plan Leasing Contract as such form is approved and amended from time to time by the Canadian Radio-television and Telecommunications Commission. In the event of discrepancy between the form of contract, if any, executed by the customer and the current form of approved contract, the terms and conditions of the latter shall govern, PROVIDED HOWEVER, in the event of inconsistency between the Company's Tariffs and the terms and conditions set forth in any form of contract, the Tariff shall govern.

The customer shall pay the following rates and charges and is subject to all applicable terms and conditions of the Company's Tariffs.
