1. OVERVIEW:

At each promotional event, the Home City and Guest City will be represented by multiple teams of 4 persons. Teams compete against each other by completing an interactive puzzle. If the puzzle is completed within the allotted time period, the team will receive (1) point for the corresponding City. At the end of the promotional event, the City which has more points will advance. The advancing City with the highest point total from among all promotional events is the winning City.‡ Sponsor will post the name of the winning City online and/or on the CAPTAIN MORGAN brand's official social media accounts.
